RESPONSE: Austin Public Health (APH) provides early childhood services through social services agreements and through direct services. The following pages detail these services by funding source.

Medicaid 1115 Waiver Funds: Austin Public Health receives Medicaid 1115 Waiver funds to implement the Maternal Infant Outreach Program (MIOP). MIOP funding levels for the past five years were the following:
