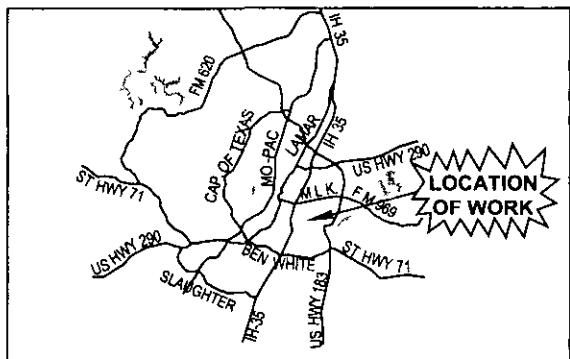
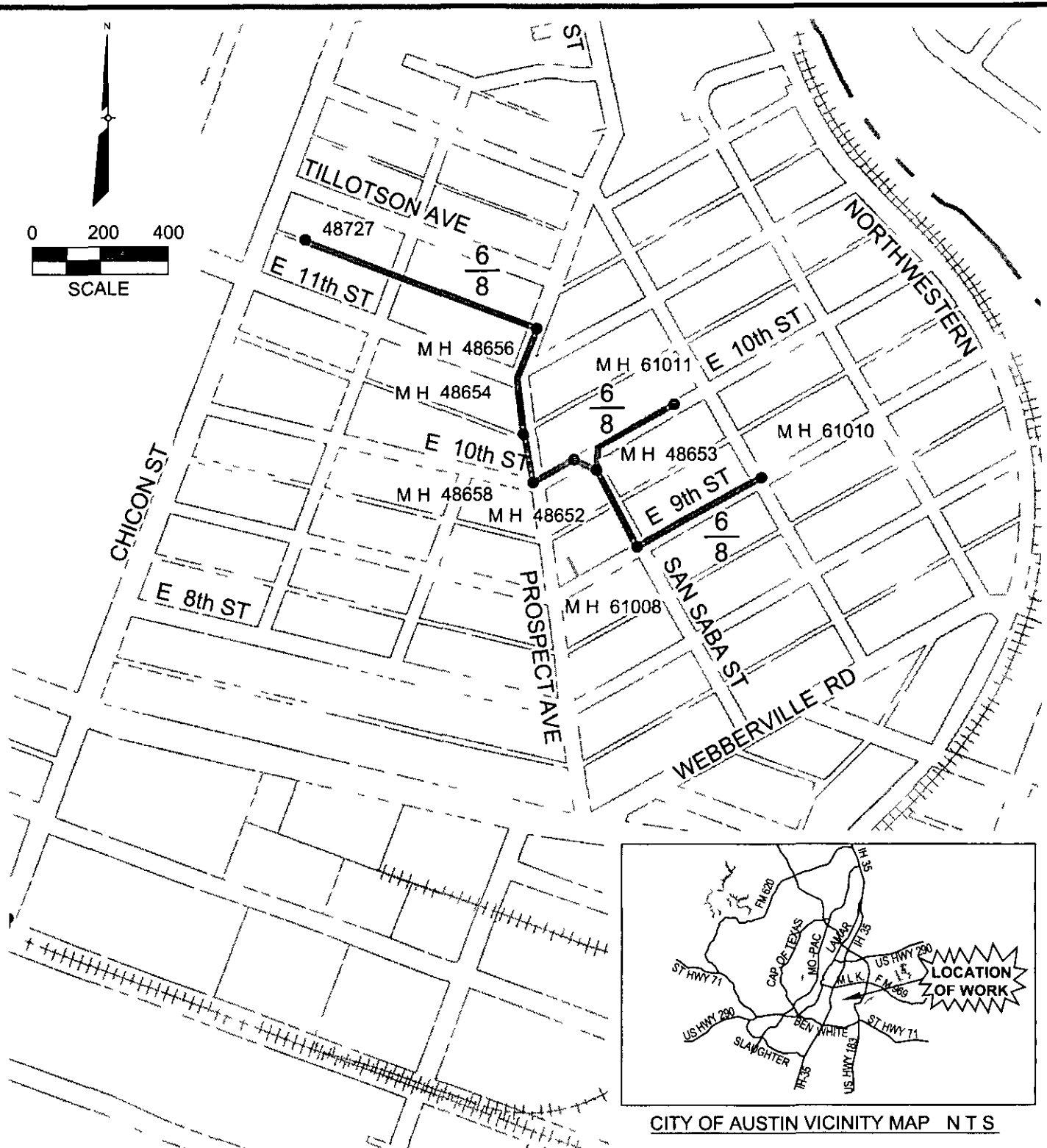
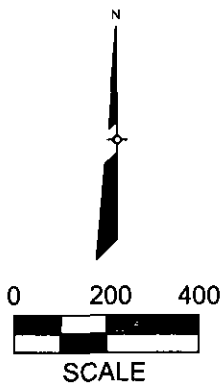
**Boards and Commission Action** Recommended by the Water and Wastewater Commission

This construction contract will provide for wastewater improvements within a mostly residential area located in the eastern section of Austin near the East 11th Street alley and Prospect Street The wastewater line being installed is located on five streets all within the right of way of the East 11th Street alley Prospect Street East 10th Street San Saba Street and East 9th Street

The improvements will replace aging and deteriorated wastewater facilities and eliminate the repeat wastewater overflows currently occurring in this area This project is part of the Austin Water Utility's Austin Clean Water Program (ACWP) which was developed to respond to the requirements of the Environmental Protection Agency's Administrative Order regarding Sanitary Sewer Overflows

This project includes construction of approximately 2 470 linear feet of 8 inch sewer (replacing the existing 6 inch pipe) by open trench construction method The proposed 8 inch sewer will connect to an existing 8 inch pipe There are 69 known private service lateral connections on this project The alley is currently paved with asphalt and will be restored with asphalt for the trench repair

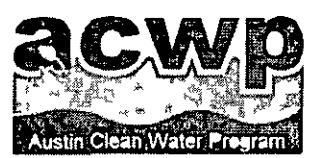
The contract allows 180 working days for completion of this project and is scheduled to begin in May 2007
