Subject Authorize award and execution of a contract with OSBURN MATERIALS INC , San Antonio, TX, for golf green mix and bunker sand in amount not to exceed \$187,790

Additional Backup Material (click to open) D OSBURN BID_TAB For More Information Cruz Banda, Buyer II/974-2133 Purchasing Language Sole bid received MBE/WBE This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) No Subcontracting opportunities were identified, therefore, no goals were established for this solicitation

This contract is for the purchase of golf green mix and bunker sand for the Jimmy Clay Golf Course renovation project that began in January 2007. The materials being purchased under this contract will be used for renovation of all the golf greens. The greens mixture consists of United States Golf Association (USGA) approved silica sand and reedsedge peat moss that will provide appropriate drainage for all greens.

Jimmy Clay's greens have suffered from poor drainage, root decline and flood damage. The greens sand mixture will be used to replace the greens structure necessary for movement of air and water through the root zone. The bunker sand is the same type sand used in the greens mix and will replace the existing bunker sand once these bunkers have been re-shaped and new drainage is installed. The improvements to the facility will improve overall playing conditions and revenue to the City of Austin Golf Division.
