**Subject** Authorize award and execution of a contract with PRIESTER-MELL & NICHOLSON INC, Austin, TX, for 138kV high strength insulators in an amount not to exceed \$49,446

**MBE/WBE** This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) No subcontracting opportunities were identified, therefore, no goals were established for this solicitation

The contract is for the purchase of 134 138kV high strength insulators. Insulators are used as a safety buffer between live electrical parts and unenergized structures in a substation. These insulators will be used for replacement of older equipment that does not meet the new mechanical requirements of the Decker Plant Substation structure. The addition of Sand Hill Power Plant has increased the amount of available fault current, which requires a higher strength insulator.
