Public Works RECOMMENDATION FOR COUNCIL ACTION

ITEM No 15

Subject Approve an ordinance amending Section 12 4 24 of the City Code to establish a maximum speed limit of 25 miles per hour on certain streets within an area bounded by Loop 360 (Capital of Texas Highway) (North) to the north Jollyville Road to the east Mesa Drive to the south and Spicewood Springs Road to the west

Amount and Source of Funding Funding in the amount of \$9 900 is available in the Fiscal Year 2006 2007 Operating Budget of the Public Works Department for the installation of necessary signs

Fiscal Note There is no unanticipated fiscal impact A fiscal note is not required

In 2005 the Legislature amended the Texas Transportation Code Section 545 356 to allow a city to set a speed limit lower than 30 miles per hour but not less than 25 miles per hour on a highway if

The highway is not an officially designated or marked highway or road in the state highway system The highway is 35 feet or less in width Vehicular parking is not prohibited on one or both sides of the street and The highway has less than four lanes used for vehicular travel

Texas Transportation Code Section 545 356 allows that the City Council may lower the speed limit along certain streets in the area bounded by Loop 360 (Capital of Texas Highway) (North) to the north Jollyville Road to the east Mesa Drive to the south and Spicewood Springs Road to the west to 25 miles per hour Most of the streets within the area are eligible under state law for a 25 mile per hour speed limit The exceptions are Adirondack Trail Hyridge Drive Mesa Drive Mountain Ridge Drive Silver Ridge Drive Westover Club Drive from Wildridge Drive to Hyridge Drive and Wildridge Drive because these streets are wider than 35 feet They are not included in the recommended Code changes

Public Works staff recommends that Section 12 4 24 be amended to add the following streets to the list of streets with a maximum speed limit of 25 miles per hour
