SUBJECT Authorize the negotiation and execution of one or more construction contracts with ILCOR HOMES INC Austin Texas to build in the Montopolis Frontier at Montana Subdivision five single family homes under the Group I bid submission in the amount of \$467,475 and five single family homes under the Group II bid submission in the amount of \$437,475 for a total amount not to exceed \$904,950

These construction contracts will provide for new construction of 10 single family homes in the Montopolis Frontier at Montana Subdivision. The single family homes will be priced below market once constructed and will serve homebuyers with low to moderate incomes. The contracts allow for 150 calendar days for completion of each home. This project is being developed in compliance with applicable federal requirements including. Title 24 Code of Federal Regulations. Section 85.40 performance goals under the Acquisition and Development Program.

The Montopolis Frontier at Montana Subdivision was developed for the construction of 81 single family affordable homeownership units. All net proceeds from the sale of the single family units will be dedicated to the construction of additional units in the subdivision.

Homes will be sold to homebuyers earning 80% of the Austin Median Family Income (MFI) or below currently \$56,900 for a family of four. The Monotopolis Subdivision's goal is to increase homeownership opportunities for low and moderate income families living in the neighborhood Habitat for Humanity has completed 5 of 20 homes in the subdivision. American Youthworks has completed 2 of 5 homes. The Austin Housing Finance Corporation (AHFC) will develop a total of 30 homes. 16 of which will be included in a Community Land Trust (CLT). Non-profit and private builders/developers may apply to the AHFC to develop the balance of 26 lots. Through the CLT and some non-profit builders residents earning 60% of the Austin MFI or less will have the opportunity for ownership.

This activity is consistent with the FY2006/2007 Action Plan as identified under Acquisition and Development

This solicitation stated that the contracts would be awarded to the lowest most responsive bidder. ILCOR Homes. Inc. submitted the lowest bid to construct the homes in accordance with the plans and specifications for the homes. ILCOR Homes line is a local builder that has built and remolded homes through out the state.
