

ORDINANCE NO.

AN ORDINANCE TO AMEND SECTION 12-4-24 OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN AN AREA BOUNDED BY RIATA TRACE PARKWAY/RIATA VISTA CIRCLE, DUVAL ROAD, U.S. HIGHWAY 183 (RESEARCH BOULEVARD), AND DORSETT ROAD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-24 (*Maximum Speed of 25 Miles Per Hour*) of the City Code is amended to add the following streets:

Acropolis Court from Whispering Valley Drive to the end of Acropolis Court.

Alpheus Avenue from Whispering Valley Drive to Acropolis Court.

Amesley Cove from Switch Willo to the end of Amesley Cove.

Audane Drive from Jessica Lane to West Cow Path.

Bar-X Drive from Pony Chase to Black Angus Drive.

Black Angus Cove from Black Angus Drive to the end of Black Angus Cove.

Branding Chase from Shetland Chase to the end of Branding Chase.

Bull Run from Mustang Chase to West Cow Path.

Bull Run Circle from West Cow Path to the end of Bull Run Circle.

Cactus Bend from Pony Chase to Rambling Range.

Chadbury Cove from Switch Willo to the end of Chadbury Cove.

Charm Circle from Whispering Valley Drive to the end of Charm Circle.

Craig Drive from Black Angus Drive to the end of Craig Drive.

Deer Track from West Cow Path to the end of Deer Track.

1 Gate Way from Duval Road to Mustang Chase.

2 Gypsy Cove from Misty Brook Drive to the end of Gypsy Cove.

3 Hereford Way from Mustang Chase to Bar-X Drive.

4 Hispania Court from Black Angus Drive to the end of Hispania Court.

5 Jessica Lane from West Cow Path to the end of Jessica Lane.

6 Maverick Drive from Mustang Chase to West Cow Path.

7 Midland Walk from Branding Chase to the end of Midland Walk.

8 Misty Brook Cove from Misty Brook Drive to the end of Misty Brook Cove.

9 Misty Brook Drive from Switch Willo to Whispering Valley Drive.

10 Mustang Chase from Duval Road to the end of Mustang Chase.

11 Ponderosa Parkway from Mustang Chase to the end of Ponderosa Parkway.

12 Pony Chase from Black Angus Drive to Cactus Bend.

13 Rambling Range from Mustang Chase to Cactus Bend.

14 Rustown Drive from Black Angus Drive to Craig Drive.

15 Saddle Circle from Bar-X Drive to the end of Saddle Circle.

16 Saddle Drive from Black Angus Drive to Bar-X Drive.

17 Sage Hen Circle from Sage Hen Drive to the end of Sage Hen Circle.

18 Sage Hen Court from Sage Hen Drive to the end of Sage Hen Court.

19 Sage Hen Cove from Sage Hen Drive to the end of Sage Hen Cove.

20 Sage Hen Drive from Black Angus Drive to Timber Wolf Trail.

1 Shetland Chase from Branding Chase to the end of Shetland Chase.
2 Smokey Mountain Drive from Black Angus Drive to Bar-X Drive.
3 Switch Willo from Whispering Valley Drive to the end of Switch Willo.
4 Timber Wolf Circle from Timber Wolf Trail to the end of Timber Wolf Circle.
5 Timber Wolf Trail from Pony Chase to the end of Timber Wolf Trail.
6 West Cow Path from 795 feet north of Duval Road to 100 feet south of Jessica
7 Lane.
8 Whispering Valley Drive from Duval Road to 1050 feet north of Duval Road.

9 **PART 2.** The City Council finds that the prima facie speed limit previously applicable to
10 the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or
11 unsafe, and the reduction in speed limit on these streets will reduce the potential for
12 vehicle-pedestrian accidents.

14 **PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical
15 order and the existing subsections renumbered accordingly.

16 **PART 4.** This ordinance takes effect on _____, 2007.
