## ORDINANCE NO.

## AN ORDINANCE TO AMEND SECTION 12-4-24 OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY WEST 29<sup>TH</sup> STREET, GUADALUPE STREET, WEST 24<sup>TH</sup> STREET, AND NORTH LAMAR BOULEVARD.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** Section 12-4-24 (*Maximum Speed of 25 Miles Per Hour*) of the City Code is amended to add the following streets:

24<sup>th</sup> ½ Street (West) between Rio Grande Street and Seton Avenue.

25<sup>th</sup> Street (West) between Lamar Boulevard (North) and Rio Grande Street.

28<sup>th</sup> <sup>1</sup>/<sub>2</sub> Street (West) between Rio Grande Street and Shoal Crest Avenue.

Hume Place between Guadalupe Street and 26<sup>th</sup> Street (West).

Odom Street between San Pedro Street and the end of Odom Street.

Pearl Street between 25<sup>th</sup> Street (West) and 26<sup>th</sup> Street (West).

Pearl Street between 29<sup>th</sup> Street (West) and the end of Pearl Street.

Salado Street between 26<sup>th</sup> Street (West) and 29<sup>th</sup> Street (West).

San Gabriel Street between Lamar Boulevard (North) and 29<sup>th</sup> Street (West).

Seton Avenue between 24<sup>th</sup> Street (West) and 25<sup>th</sup> Street (West).

Shoal Cliff Court between San Pedro Street and the end of Shoal Cliff Court.

**PART 2.** The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.
