The Water and Wastewater Commission recommends authorization to approve a resolution authorizing the acquisition for the US 183-Springdale to Martin Luther King Project for a water line easement of 0.138 acre (6,024 square feet) in the J. C. Tannehill League, being part of Lot 1 and Lot 2, First Resubdivision Tract No. 2, Bluestein Shopping Center; water line easement of 0.393 acre (17,119 square feet) in the J. C. Tannehill League; a wastewater line easement of 0.171 acre (7,459 square feet) in the J.A.G. Brook Survey No. 28, and a temporary working space easement of 0.114 acre (4,976 square feet) in the J.A.G. Brook Survey No. 28, situated in Travis County, Texas, and incorporated for all purposes (collectively called the "Property") located on Ed Bluestein Boluvard and Loyola Lane, Austin, Travis County, Texas, from the **AUSTIN INDEPENDENT SCHOOL DISTRICT** in the amount not to exceed \$89,390.
