

**ORDINANCE NO.**

**AN ORDINANCE AMENDING SECTION 12-4-63 OF THE CITY CODE AND ORDINANCE NO. 20070809-004 TO MODIFY THE 20 MILE PER HOUR SCHOOL ZONE ON A PORTION OF CONGRESS AVENUE FOR FULMORE MIDDLE SCHOOL AND TRAVIS HEIGHTS ELEMENTARY SCHOOL; AND PROVIDE FOR EMERGENCY PASSAGE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The council finds that:

- (A) Ordinance No. 20070809-004 repeals and replaces Chapter 12-4 (*Speed Limits*) of the City Code and, to allow time for administrative coordination, is effective on September 1, 2007.
- (B) It is necessary to amend both the current Chapter 12-4, which is being repealed but is in effect through August 31, 2007, and the new Chapter 12-4.

**PART 2.** Section 12-4-63 (*20 Mile Per Hour School Zones*) of the City Code is amended by modifying the Congress Avenue school zone for Fulmore Middle School and Travis Heights Elementary School to read:

Congress Avenue (South) from 65 feet north of Johanna Street [~~227 feet north of the north curb line of West Mary Street (station 111 + 93)~~] to Crockett Street [244 feet south of the south curb line of Leland Street (station 123 + 42)] (Fulmore Middle School/Travis Heights Elementary School).

**PART 3.** Section 12-4-64 (D) of Ordinance No. 20070809-004 is amended by modifying the Congress Avenue school zone for Fulmore Middle School and Travis Heights Elementary School to read:

Congress Avenue (South) from 65 feet north of Johanna Street [~~227 feet north of the north curb line of West Mary Street (station 111 + 93)~~] to Crockett Street [244 feet south of the south curb line of Leland Street (station 123 + 42)] (Fulmore Middle School/Travis Heights Elementary School).

**PART 4.** Council finds that school is in session, and this constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health and safety. Section 2 of this
