Staff Report

Staff recommends that the City Council approve an ordinance authorizing the issuance of City of Austin, Texas, Public Improvement Bonds, Series 2007, in the amount of \$97,525,000. Attachment A details the specific projects associated with this proposed issuance.. Of the \$97,525,000 in Public Improvement Bonds to be issued, \$90,425,000 will be issued to provide funding for reimbursement resolutions already approved by Council.

With this sale, the remaining general obligation bond authorizations will be as follows:

The recommended debt issuance will be competitively bid with all the members of the City's two underwriting teams. Bids will be verified by the City's Financial Advisor, Public Financial Management, Inc.

With this sale, the City's outstanding general obligation bonds will total \$971,136,964 including \$217,299,547 in self-supporting debt.
