

REGULAR MEETING THURSDAY, AUGUST 23, 2007

Invocation: Pastor Abraham Perez, Ebenezer Family Worship Center

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, August 23, 2007 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Wynn called the Council Meeting to order at 10:18 a.m.

The Mayor asked Council Members to report on upcoming agenda items:

Council Member Kim announced she will be talking to the Robert Mueller Municipal Airport Plan Implementation Advisory Commission concerning fitness and wellness subsidies that might be provided to the surrounding neighborhoods by the medical facilities located in this development.

Council Member Leffingwell announced that recommendations for retrofitting water quality features in the Barton Springs area will be presented to groups around the city and brought to Council for consideration on October 11.

CONSENT AGENDA

The following items were acted on by one motion. No separate discussion or action occurred on any of the items. The consent items were approved on Mayor Pro Tem Dunkerley's motion, Council Member Cole's second on a 7-0 vote.

- 1. Approval of the minutes of the Austin City Council from the regularly scheduled meeting of August 9, 2007.
 - The minutes from the meeting of August 9, 2007 were approved.
- 2. Authorize the City Manager to negotiate and execute an agreement with Brushy Creek Municipal Utility District ("Brushy Creek") for the provision of out-of-district water and wastewater service to approximately 10 acres located adjacent to Brushy Creek's southern boundary. Brushy Creek and the landowners will be responsible for the necessary infrastructure improvements. No City funding is required for this agreement. Recommended by the Water and Wastewater Commission.
 - The motion authorizing the City Manager to negotiate and execute an agreement with Brushy Creek Municipal Utility District was approved.
- 3. Authorize the City Manager to negotiate and execute an agreement with River Place Municipal Utility District ("River Place") for the provision of out-of-district water service to an approximately 9.9 acre tract located near River Place's eastern boundary. River Place and the developer will be responsible for the

necessary infrastructure improvements. No City funding is required for this agreement. Recommended by the Water and Wastewater Commission.

The motion authorizing the City Manager to negotiate and execute an agreement with River Place Municipal Utility District was approved.

- 4. Authorize negotiation of a lease and related documents and agreements with GE Commercial Aviation Services, LLC for up to 40 acres of land at Austin-Bergstrom International Airport for the construction, operation and maintenance of a low cost "no-frills" airport terminal, and associated uses including, but not limited to, car parking, rental car facilities, and ground transportation staging for a term not to exceed thirty years from the date of beneficial occupancy of the new terminal at a rental of not less than \$0.22 per square foot plus a percentage of net revenue. Recommended by the Austin Airport Advisory Commission. The motion authorizing the negotiation of a lease and related documents and agreements with GE Commercial Aviation Services, LLC was approved.
- 5. Approve an ordinance authorizing acceptance of \$2,845 in grant funds from the TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS, Austin, TX; and amending the Fiscal Year 2006-2007 Health and Human Services Department Operating Budget Special Revenue Fund of Ordinance No. 20060911-001 to appropriate \$2,845 for a total grant amount of \$805,977 for the delivery of basic needs and other self-sufficiency resources for low-income residents. Funding is available from the Texas Department of Housing and Community Affairs, Community Services Block Grant program. The grant period is January 1, 2006 through December 31, 2007. No City match is required.

 Ordinance No. 20070823-005 was approved.
- 6. Approve an ordinance authorizing acceptance of \$89,059 in grant funds from the TEXAS DEPARTMENT OF STATE HEALTH SERVICES, Austin, TX; and amending the Fiscal Year 2006-2007 Health and Human Services Department Operating Budget Special Revenue Fund of Ordinance No. 20060911-001 to appropriate \$89,059 for a total grant amount of \$368,059 for the Tuberculosis Elimination and Control program to provide basic services for tuberculosis prevention and control. Funding is available from the Texas Department of State Health Services, Infectious Disease Intervention and Control Branch, Austin, TX. The grant period is September 1, 2007 through August 31, 2008. No City match is required.

Ordinance No. 20070823-006 was approved.

- 7. Approve an amendment to the outside counsel contract with Foley & Lardner, LLP, Orlando, FL, for legal counsel concerning advice and representation of the Department of Aviation regarding leases and other agreements related to the development of a new low cost terminal at Austin-Bergstrom International Airport, in the amount of \$75,000, for a total contract amount not to exceed \$124,000. Funding is available in the Fiscal Year 2006-2007 Operating Budget of the Department of Aviation.
 - The motion authorizing an amendment to the outside counsel contract with Foley and Lardner, LLP was approved.
- 8. Authorize negotiation and execution of an agreement with Citibank N.A. for the reimbursement of streetscape improvement costs for the project located at 611 West 5th Street (Block 47, Lots 7 & 8, Original City of Austin subdivision), under the Great Streets Development Program, in an amount not to exceed \$100,411. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Neighborhood Planning and Zoning Department from Great Streets Parking Meter Revenue.
 - The motion authorizing the negotiation and execution of an agreement with Citibank N.A. was approved.

- 9. Approve an ordinance authorizing the acceptance of \$23,680 in grant funds from the Capital Area Council of Governments (CAPCOG), Austin, TX; and amending the Fiscal Year 2006-2007 Parks and Recreation Department Operating Budget Special Revenue Fund of Ordinance No. 20060911-001 to appropriate \$23,680 for a total grant amount of \$328,680 for the Senior Nutrition Program at various locations within the City of Austin and Travis County. Funding in the amount of \$23,680 is available from the Capitol Area Council of Governments, Austin, TX. The grant period is September 1, 2006 through September 30, 2007. The City's required match is \$6,660.
 - Ordinance No. 20070823-009 was approved.
- 10. Approve an ordinance rejecting the 1985 proposed dedication of public right-of-way and accepting a dedication of approximately .63 acres of additional parkland easements and alternate right-of-way access and parking facilities for the Walnut Creek Greenbelt located at the mouth of Walnut Creek at the Colorado River adjacent to Delwau Lane approximately 1/2 mile east of US 183.

 This item was withdrawn.

Item 11 was pulled for discussion.

12. Approve the negotiation and execution of an exchange agreement for temporary staging and material storage easements on Tract B, approximately 0.151 acres and Tract A being 0.287 acres both Tracts out of and a part of the property known as 1132 Northwestern Drive from the heirs of Allen Harrell Sr. for the release of a wastewater easement and other interests on Tract B, for a net consideration not to exceed \$22,481 for the Austin Clean Water Program: Manor/Comal Project. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Recommended by the Water and Wastewater Commission.

The motion authorizing the negotiation and execution of an exchange agreement for temporary staging and material storage easements on Tract B and Tract A, 1132 Northwestern Drive, was approved.

13. Authorize execution of a construction contract with MCLEAN CONSTRUCTION, LTD., Killeen, TX, for the Austin Clean Water Program: Govalle SSO - West 5th-6th Street Sanitary Sewer Replacement Project in the amount of \$5,733,318 plus a \$286,666 contingency for a total contract amount not to exceed \$6,019,984. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Lowest of three bids received. This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) by meeting the goals with 13.23% MBE and 12.66% WBE subcontractor participation. Recommended by Water and Wastewater Commission.

The motion authorizing the execution of a construction contract with McLean Construction, Ltd. was approved.

14. Authorize execution of a construction contract with AUSTIN FILTER SYSTEMS, INC., Austin, TX, for the Austin Clean Water Program: Govalle 3 - Parker Lane/Metcalfe Road Wastewater Improvements Project Re-Bid in the amount of \$2,958,923 plus a \$147,946 contingency, for a total contract amount not to exceed \$3,106,869. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Lower of two bids received. This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) by meeting the goals with 14.16% MBE and 12.74% WBE subcontractor participation. Recommended by the Water and Wastewater Commission.

The motion authorizing the execution of a construction contract with Austin Filter Systems, Inc. was approved.

15. Authorize execution of a construction contract with HAEGELIN CONSTRUCTION CO., LTD., Austin, TX, for the Austin Clean Water Program: Govalle 2 - Travis Heights Wastewater Improvements Project in the amount of \$3,160,788.40 plus a \$158,040 contingency, for a total contract amount not to exceed \$3,318,828.40. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Lowest of three bids received. This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) through the achievements of Good Faith Efforts of 17.78% MBE and 8.39% WBE subcontractor participation. Recommended by the Water and Wastewater Commission.

The motion authorizing the execution of a construction contract with Haegelin Construction Company, Ltd was approved.

16. Authorize execution of a construction contract with PORT ENTERPRISES, LTD., Manchaca, TX, for the Austin Convention Center Roof Replacement Project in the amount of \$3,946,734 plus a \$400,000 contingency, for a total contract amount not to exceed \$4,346,734. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Convention Center Department. Lowest of five bids received. This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) through the achievements of Good Faith Efforts of 0% MBE and 0.72% WBE subcontractor participation.

The motion authorizing the execution of a construction contract with Port Enterprises, Ltd. was approved.

17. Authorize negotiation and execution of a professional services agreement with KENNEDY/ JENKS CONSULTANTS, INC., Austin, TX, for engineering services for the Operation and Maintenance Management System (OMMS) for Wastewater Treatment and Biosolids Management Plants Project, in an amount not to exceed \$1,200,000. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Best qualification statement of seven statements received. This contract will be awarded in compliance with Chapter 2-9B of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). Due to the limited subcontracting opportunities, no MBE/WBE participation goals were established for this solicitation. Recommended by the Water and Wastewater Commission.

This item was withdrawn.

18. Authorize negotiation and execution of an amendment to the Interlocal Agreement between the City of Austin and the CAPITAL METROPOLITAN TRANSPORTATION AUTHORITY for development and funding of the extensions of Rundberg Lane and Saunders Lane. Recommended by the Urban Transportation Commission.

The motion authorizing the negotiation and execution of an amendment to the interlocal agreement between the City of Austin and the Capital Metropolitan Transportation Authority was approved.

Items 19 and 20 were pulled for discussion.

21. Approve an ordinance amending Section 12-4-63 of the City Code and Ordinance No. 20070809-004 to establish a 20 mile per hour school zone on Curlew Drive from 250 feet south of Kentish Drive to 200 feet north of Kentish Drive for Cowan Elementary School; and provide for emergency passage. Funding in the amount of \$13,200 is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department for the installation of necessary signs.

Ordinance No. 20070823-021 was approved.

22. Authorize award and execution of two 24-month requirements supply contracts with ACT PIPE & SUPPLY, Pflugerville, TX and TECHLINE PIPE L.P., Austin, TX for the purchase of ball and gate

valves of various sizes in estimated amounts not to exceed \$255,573 and \$111,678 respectively, with two 12-month extension options in estimated amounts not to exceed \$127,787 and \$55,839 respectively per extension option, for total estimated contract amounts not to exceed \$511,147 and \$223,356 respectively. Funding in the amount of \$30,605 is available in Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining 22 months of the original contract periods and extension options is contingent upon available funding in future budgets. Lowest bids of five bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation. Recommended by the Water and Wastewater Commission.

The motion authorizing the award and execution of two requirements supply contracts with Act Pipe and Supply and Techline Pipe L.P. was approved.

Authorize award and execution of a 12-month requirements service contract with KUBCO DECANTER SERVICES, INC., Houston, TX for the repair of water treatment centrifuges for the Austin Water Utility in an estimated amount not to exceed \$103,550, with three 12-month extension options in an estimated amount not to exceed \$414,200. Funding in the amount of \$8,629 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining eleven months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program.) No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. Recommended by the Water and Wastewater Commission.

The motion authorizing the award and execution of a requirements service contract with Kubco Decanter Services, Inc. was approved.

24. Authorize award and execution of a 24-month requirements supply contract with MUNICIPAL WATER WORKS SUPPLY, LP, Royse City, TX, for the purchase of ductile iron fittings and pipe joint restraints of various sizes in an estimated amount not to exceed \$100,855, with two 12-month extension options in an estimated amount not to exceed \$50,428 per extension option, for a total estimated contract amount not to exceed \$201,711. Funding in the amount of \$8,405 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining 22 months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of three bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation. Recommended by the Water and Wastewater Commission.

The motion authorizing the award and execution of a requirements supply contract with Municipal Water Works Supply, LP was approved.

25. Authorize award and execution of a 24-month requirements service contract with N-LINE TRAFFIC MAINTENANCE (WBE/FR 100%), Austin, TX, for the rental of temporary traffic control devices and roadway pavement marking services in an estimated amount not to exceed \$980,000, with three 12-month extension options in an estimated amount not to exceed \$490,000 per extension option, for a total estimated contract amount not to exceed \$2,450,000. Funding in the amount of \$17,918 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding in the amount of \$6,666 is available in the Operating Budget of the Public Works Department. Funding in the amount of \$8,333 is available in the Operating Budget of Watershed Protection and Development Review Department. Funding in the amount of \$5,000 is available in the Operating Budget of Austin Energy. Funding in the

amount of \$2,916 is available in the Operating Budget of the Parks and Recreation Department. Funding for the remaining 23 months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program.) No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. Recommended by the Water and Wastewater Commission.

Authorize award and execution of a 12-month requirements supply contract with SECURITY SAFETY & SUPPLY, Houston, TX, for portable water coolers and associated replacement parts in an estimated amount not to exceed \$72,169, with two 12-month extension options in an estimated amount not to exceed \$75,779 for the first extension option and \$79,567 for the second extension option, for a total estimated contract amount not to exceed \$227,515. Funding in the amount of \$6,014 is available in the Fiscal Year 2006-2007 Operating Budget of the Financial & Administrative Services Department. Funding for the remaining 11 months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the award, negotiation and execution of a requirements service contract with Alliance Work Partners was approved.

Funding in the amount of \$15,022 is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department. Funding for the remaining twenty-three months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of four bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.
