If adopted, the proposed new water and wastewater impact fees will become effective on October 1, 2007.

The Impact Fee Advisory Committee comments have been completed and will be provided to the Mayor and Council, before the fifth business day prior to the public hearing on the proposed amendments, in accordance with statute

All Impact Fee Advisory Committee recommendations have been incorporated in the revised Impact Fee Land Use Assumptions and Capital Improvements Plan (CIP) reports. The recommended report changes include a minor calculation correction, which resulted in a change of the maximum allowable fee for water from \$3,310 to \$3,308. An additional minor adjustment to the water service units was also made, which resulted in the maximum allowable fee changing to \$3,307. Due to the process of rounding the

actual fee schedule amounts to the nearest \$100, these changes did not result in a change to the proposed fees to be charged.

Under the law, the Council must approve or reject the proposed update on or before the expiration of thirty (30) days from the date of the public hearing on the amendments.

The public hearing notification was published on July 30, 2007 in the Austin American-Statesman.
