**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

- (A) Notice of the two public hearings concerning annexation of the territory described in Exhibit A was published in a newspaper of general circulation in the City of Austin and in the area to be annexed, and on the City of Austin internet website.
- (B) The public hearings were held on August 23, 2007 and August 30, 2007 at the Austin City Hall, 301 West 2<sup>nd</sup> Street, Austin, Texas.
- (C) The public hearings were concluded after providing an opportunity for all persons present to be heard with respect to the proposed annexation. A proposed Service Plan was made available and explained at the public hearings required by state law.
- (D) The annexation, for full purposes, of the territory described in Exhibit A serves the interest of the current and future residents of the City of Austin.
- (E) All procedural requirements imposed by state law for the full purpose annexation of the territory described in Exhibit A have been met.

Ten tracts of land, the tract hereinafter described as Tract One containing approximately 417.93 acres of land out of the Jose Antonio Navarro Grant, Abstract 18 in Travis County, Texas; the tract of land hereinafter described as Tract Two containing approximately 240.00 acres of land out of the Santiago Del

1 Valle Grant, Abstract 24 in Travis County, Texas; the tract of land hereinafter  
2 described as Tract Three containing approximately 180.00 acres of land out of the  
3 Jose Antonio Navarro Grant, Abstract 18 and the Santiago Del Valle Grant,  
4 Abstract 24 in Travis County, Texas; the tract of land hereinafter described as  
5 Tract Four containing approximately 109.2 acres of land out of the Santiago Del  
6 Valle Grant, Abstract 24 in Travis County, Texas; the tract of land hereinafter  
7 described as Tract Five containing approximately 12.148 acres of land out of the  
8 Santiago Del Valle Grant, Abstract 24 in Travis County, Texas; the tract of land  
9 hereinafter described as Tract Six containing approximately 10.084 acres of land  
10 out of the Santiago Del Valle Grant, Abstract 24 in Travis County, Texas; the tract  
11 of land hereinafter described as Tract Seven containing approximately 3.14 acres  
12 of land out of the Jose Antonio Navarro Grant, Abstract 18 in Travis County,  
13 Texas; the tract of land hereinafter described as Tract Eight containing  
14 approximately 1.5612 acres of land out of the Santiago Del Valle Grant, Abstract  
15 24 in Travis County, Texas; the tract of land hereinafter described as Tract Nine  
16 containing approximately 10 acres of land out of the Jose Antonio Navarro Grant,  
17 Abstract 18 and the Santiago Del Valle Grant, Abstract 24 in Travis County,  
18 Texas; and the tract of land hereinafter described as Tract Ten containing  
19 approximately 1 acre of land out of the Santiago Del Valle Grant, Abstract 24 in  
20 Travis County, Texas, of which 985 acres of land, more or less, are to be taken into  
21 and made a part of the City of Austin, Travis County, Texas; said 985 acres of  
22 land, more or less, being more particularly described in Exhibit A.

23 **PART 3.** The Service Plan attached as Exhibit B is approved as the Service Plan for the  
24 area.

25  
26 **PART 4.** The City Council declares that its purpose is to annex to the City of Austin  
27 each part of the area described in Exhibit A as provided in this ordinance, whether any  
28 other part of the described area is effectively annexed to the City. If this ordinance is  
29 held invalid as to any part of the area annexed to the City of Austin, that invalidity does  
30 not affect the effectiveness of this ordinance as to the remainder of the area.

31  
32 If any area or lands included within the description of the area set out in Exhibit A are:  
33 (1) presently part of and included within the general limits of the City of Austin; (2)  
34 presently part of and included within the limits of any other city, town, or village; or (3)  
35 are not within the jurisdiction or power of the City of Austin to annex, then that area is  
36 excluded and excepted from the area annexed.
