

The Water and Wastewater Commission recommends authorization to award and execute four 24-month requirements supply contract with **ACT PIPE & SUPPLY**, Pflugerville, TX, **HYDROFLO, INC.**, Beaumont, TX, **HD SUPPLY WATERWORKS**, Round Rock, TX and **MUNICIPAL WATER WORKS SUPPLY, L.P.**, Royce City, TX for the purchase of various hydrant repair parts for the Austin Water Utility in an estimated amounts not to exceed \$1,125,656.00, \$331,114.80, \$205,250.00, and \$101,974.00 with two 12-month extension options in an amount not to exceed \$562,828.00, \$165,557.40, \$102,625.00 and \$50,987.00 respectively per extension option, for a total contract amount not to exceed \$2,251,312.00, \$662,229.60, \$410,500.00 and \$203,948.00 respectively.
