

ORDINANCE NO. 20070927-096

AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 11200 ZIMMERMAN LANE FROM DEVELOPMENT RESERVE (DR) DISTRICT TO SINGLE FAMILY RESIDENCE LARGE LOT (SF-1) DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from development reserve (DR) district to single family residence large lot (SF-1) district on the property described in Zoning Case No C14-2007-0089, on file at the Neighborhood Zoning and Planning Department, as follows

A 20 1982 acre tract of land, more or less, out of the John E Linn Survey No 804, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance,

locally known as 11200 Zimmerman Lane, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B"

PART 2. This ordinance takes effect on October 8, 2007

METES AND BOUNDS DESCRIPTION

Being all that certain 20 1982 acre tract or parcel of land situated in the JOHN E LINN SURVEY NO 804, Travis County, Texas, and being that same tract called 20 219 acres as described in Deed to Ordell Dube recorded in Volume 3559, Page 1027, Travis County Deed Records (TCDR), and being more particularly described by metes and bounds as follows, to-wit

BEGINNING at an iron rod found marking the Southeast corner hereof, same being the Southwest corner of Lot 1, WTP NO 4 ADDITION, a subdivision according to the map or plat thereof recorded in Volume 86, Page 190-D, Travis County Plat Records, and being further located in the North line of that certain 308 581 acre tract as described in Deed to PWB Joint Venture recorded in Volume 8694, Page 676, Travis County Real Property Records (TCRPR),

THENCE, with the East line hereof, and the West line of said Lot 1, the following five (5) courses and distances

- (1) North 29°41'55" East-127 85 feet to a concrete monument found,
- (2) North 29°17'00" East-302 33 feet to an iron rod found,
- (3) North 30°30'55" East-171 63 feet to an iron rod found,
- (4) North 28°38'30" East-139 49 feet to an iron rod found, and
- (5) North 30°50'50" East-131 25 feet to an iron rod found marking the Northeast corner hereof, and an interior corner of said Lot 1,

THENCE, with the North line hereof, and the South line of said Lot 1, and the South line of that certain 41 16 acre tract as described in Deed to DWDTHD Land No 5, LLC, recorded in Document No 2003198748, Travis County Official Public Records, the following six (6) courses and distances

- (1) North 59°48'25" West-229 92 feet to an iron rod set for angle point,
- (2) North 58°46'05" West-164.14 feet to an iron pipe found marking the common South corner of said Lot 1 and said 41 16 acre tract,
- (3) North 61°03'50" West- 40 07 feet to a nail found,
- (4) North 60°40'20" West-174 57 feet to a nail found,
- (5) North 60°34'45" West-149 91 feet to a nail found, and
- (6) North 58°30'20" West-168 99 feet to a nail found marking the common South corner of said 41 16 acre tract and that certain 30 23 acre tract as described in Deed to Northwest Austin M U D No 1 recorded in Volume 12847, Page 378, TCRPR,

THENCE, North 60°32'55" West, with the South line of said 30 23 acre tract and the North line hereof, a distance of 76 10 feet to an iron rod with cap found marking the Northwest corner hereof,

THENCE, South 29°11'55" West, with the West line hereof and the East line of that certain 4 00 acre tract as described in Deed to R G Thomas recorded in Volume 5492, Page 292, TCDR, a distance of 366 35 feet to an iron rod found,





THENCE, South 60°47'40" East, with the South line hereof and the said North line of the 308 581 acre tract, a distance of 996 14 feet to the POINT OF BEGINNING and containing 20 1982 acres of land
