- 4 Update on the transfer of the Community Care Services Department to the Travis County Healthcare District (Trish Young, President & CEO Travis County Healthcare District)

Trish Young presented to the subcommittee on the transfer of the City of Austin's Community Care Services Department to the Healthcare District The governance structure would have separate Boards the Healthcare District Board of Managers to run the district activities and the FQHC Board to run the 501 (c) 3 Community Health Centers (CHCs) The employment compensation package though admittedly not as generous as the City's will include competitive market salaries and benefits Council Member Martinez requested employee association agencies be made accessible to staff transferring from City employment to the Healthcare District The District has engaged in an extensive communications strategy with employees notifying them of upcoming changes It is anticipated the new entity the District CHCs will become operational in March 2009

David Lurie Director of the City of Austin Health and Human Services Department (HHSD) presented on the Public Health Services Interlocal
