ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY DAVIS LANE AND GUIDEPOST TRAIL TO THE NORTH, MANCHACA ROAD TO THE EAST, WEST SLAUGHTER LANE TO THE SOUTH, AND BRODIE LANE TO THE WEST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

Davis Lane from Brodie Lane to Guidepost Trail [Kentish Drive to Zeke Bend].

Leo Street from Guidepost Trail to Cameron Loop [Davis Lane].
