ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE TWO NEIGHBORHOOD AREAS BOUNDED BY: 1) EAST RUNDBERG LANE TO THE NORTH, I.H. 35 (NORTH) WEST FRONTAGE ROAD TO THE EAST, EAST ANDERSON LANE TO THE SOUTH, AND NORTH LAMAR BOULEVARD TO THE WEST, AND 2) DUNGAN LANE TO THE NORTH, WALL STREET TO THE EAST, CROSS PARK DRIVE TO THE SOUTH, AND CAMERON ROAD/DESSAU ROAD TO THE WEST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Beaver Street from Georgian Drive to Lamar Boulevard (North).

Brown Lane from Ferguson Lane to 420 feet north of Dungan Lane.

Capitol Drive from East Drive to Middle Lane.

Carpenter Avenue from Slayton Drive to Lamar Boulevard (North).

Deen Avenue from Georgian Drive to Lamar Boulevard (North).

Dungan Lane from 65 feet east of Dessau Road to Brown Lane.

Dungan Street from Pecan Drive to Walnut Drive (East).

East Drive from Fawnridge Drive (East) to Florence Drive.

Elliott Street (West) from Georgian Drive to Lamar Boulevard (North).

Fawnridge Drive (East) from Georgian Drive to the end of Fawnridge Drive (East).

Fawnridge Drive (West) from Georgian Drive to Slayton Drive.

1 Ferguson Lane from 232 feet east of Cameron Road to 510 feet east of Leisure Drive. 2 3 4 Florence Drive from Georgian Drive to the end of Florence Drive. 21 22	PART 2. The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or

unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.

PART 3. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.
