## ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS BOUNDED BY EAST OLTORF STREET TO THE NORTH, BURLESON ROAD TO THE EAST, EAST BEN WHITE BOULEVARD TO THE SOUTH, AND IH 35 EAST SERVICE ROAD TO THE WEST.

**PART 1.** Section 12-4-64(D) (Table of Speed Limits) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:
