## ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY SOUTH LAMAR BOULEVARD AND WEST BEN WHITE BOULEVARD TO THE NORTH, MANCHACA ROAD TO THE EAST, WEST STASSNEY LANE TO THE SOUTH, AND WEST GATE BOULEVARD TO THE WEST.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

Fair Oaks Drive from Buffalo Pass to Calais Court [Manchaca Road].

**PART 2.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Apache Pass from Tejas Trail to Pack Saddle Pass.

Arapahoe Pass from Pack Saddle Pass to the end of Arapahoe Pass.

Arapahoe Trail from Pack Saddle Pass (north intersection) to Pack Saddle Pass (south intersection).

Broken Bow Pass from Remuda Trail to Buckskin Pass.

Buckskin Pass from Broken Bow Pass to Jones Road.

Buffalo Pass from Jones Road to Remuda Trail.

Cactus Lane from Roundup Trail to Cimarron Trail.

Cactus Lane from Redd Street to Ben White Boulevard (West).

Chasewych Drive from Fernview Road to Cork Path.

Cheyenne Circle from Buckskin Pass to the end of Cheyenne Circle.

15	unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the
16	potential for vehicle-pedestrian accidents.

18	PART 4. The amendments made in this ordinance shall be incorporated in alphabetical
19	order and the existing subsections renumbered accordingly.
