

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY WEST OLTORF STREET TO THE NORTH, SOUTH 1ST STREET TO THE EAST, WEST BEN WHITE BOULEVARD TO THE SOUTH, AND UNION PACIFIC RAIL ROAD TO THE WEST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

 2^{nd} Street (South) from [Oltorf Street (West) to] Monroe Street (West) to the end of 2^{nd} Street (South).

4th Street (South) from Oltorf Street (West) to the <u>southern</u> end of 4th Street (South).

Oak Crest Avenue from 3rd Street (South) to the end of Oak Crest Avenue [Oltorf Street (West)].

PART 2. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

- 2nd Street (South) from Audrey Drive to the end of 2nd Street (South).
- 2nd Street (South) from Herndon Lane to Huerta Street.
- 3rd Street (South) from Herndon Lane to Huerta Street.
- 3rd Street (South) from Oltorf Street (West) to the end of 3rd Street (South).
- 4th Street (South) from Juanita Street to Terrell Hill Drive.
- 4th Street (South) from Terrell Hill Drive to Limon Lane.
- 5th Street (South) from Juanita Street to Cardinal Lane.

2	Audrey Drive from 2 nd Street (South) to Garden Villa Lane.		
3	Audrey Court from Garden Villa Lane to the end of Audrey Court.

9	Daphne Court from Garden Villa Lane to the end of Daphne Court.		
10	Fieldcrest Drive from 6 th Street (South) to Havenside Drive.		
11	Flanagan Cove from Raywood Drive to the end of Flanagan Cove.		
12	Gamez Cove from 2 nd Street (South) to the end of Gamez Cove.		
13	Garden Villa Court from Garden Villa Lane to the end of Garden Villa Court.		
14	Garden Villa Lane from Banister Lane to the end of Garden Villa Lane.		
15	Havenside Drive from Oltorf Street (West) to Fieldcrest Drive.		
16	Herndon Lane from 1 st Street (South) to the end of Herndon Lane.		
17	Huerta Street from 2 nd Street (South) to 3 rd Street (South).		
18	Juanita Street from 4 th Street (South) to the end of Juanita Street.		
19	Limon Lane from 4 th Street (South) to the end of Limon Lane.		
20	Locke Lane from Cardinal Lane to the end of Locke Lane.		

1	Marcae Court from Audrey Drive to the end of Marcae Court.		
2	Oak Crest Avenue from Peacock Lane to Herndon Lane.		
3	Peacock Lane from 1 st Street (South) to Oak Crest Avenue.		
4	Raywood Drive from Barton Skyway to Locke Lane.		
5	South Center Street from Birch Street to the end of South Center Street.		
6	Southwood Road from Havenside Drive to 6 th Street (South).		
7	Taffy Court from Garden Villa Lane to the end of Taffy Court.		
8	Terrell Hill Drive from 1 st Street (South) to 5 th Street (South).		
9	Twelve Oaks Lane from 1st Street (South) to the end of Twelve Oaks Lane.		
10	Villa Court from Audrey Drive to the end of Villa Court.		
11	Weathers Lane from Locke Lane to the end of Weathers Lane.

13	PART 3. The City Council finds that the prima facie speed limit previously applicable to		
14	the streets, or portions of streets, identified in Parts 1 and 2 of this ordinance is		
15	unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the		
16	potential for vehicle-pedestrian accidents.

18	PART 4. The amendments made in this ordinance shall be incorporated in alphabetical		

order and the existing subsections renumbered accordingly.
