ORDINANCE NO.

AN ORDINANCE TO AMEND SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY WILLIAM CANNON DRIVE TO THE NORTH, PLEASANT VALLEY ROAD TO THE EAST, BLUFF SPRINGS ROAD TO THE WEST, AND ONION CREEK TO THE SOUTH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Alegre Pass from Bluff Springs Road to Tranquilo Trail.

Andrea Woods Cove from Stonleigh Place to the end of Andrea Woods Cove.

Ashley Way from Poinsetta Lane to the end of Ashley Way.

Avalon Avenue from Vougeot Drive to the end of Avalon Avenue.

Bendridge Trail from Stonleigh Place to Branchwood Drive.

Bitter Creek Drive from Bluff Springs Road to Rockridge Drive.

Bitteroot Trail from Blue Meadow Drive to Bucks Run.

Bluestone Street from Bendridge Trail to the end of Bluestone Street.

Borage Drive from Silverstone Drive to Quicksilver Boulevard.

Bourg Cove from Avalon Avenue to the end of Bourg Cove.

Branchwood Drive from Blue Meadow Drive to William Cannon Drive (East).

Bucks Run from Trendal Lane to Meadow Lake Boulevard.

Buttonbush Drive from Savorey Lane to Quicksilver Boulevard.

The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents. PART 3. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.
