AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY SOUTH LAMAR BOULEVARD AND WEST BEN WHITE BOULEVARD TO THE NORTH, MANCHACA ROAD TO THE EAST, WEST STASSNEY LANE TO THE SOUTH, AND WEST GATE BOULEVARD TO THE WEST.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (Table of Speed Limits) of the City Code is amended to read

Fair Oaks Drive from Buffalo Pass to Calass Court [Manchaea Road]
PART 2. Section 12-4-64(D) (Table of Speed Limits) of the City Code is amended to add the following street sections with 25 mile per hour speed limits

Apache Pass from Tejas Trall to Pack Saddle Pass
Arapahoe Pass from Pack Saddle Pass to the end of Arapahoe Pass
Arapahoe Traıl from Pack Saddle Pass (north intersection) to Pack Saddle Pass (south intersection)

Farrhill Drive from Fairmont Circle to Southern Oaks Drıve

Fairmont Circle from Village Way Drıve (west intersection) to Southern Oaks Drıve

Frontier Trall from Western Tralls Boulevard to Manchaca Road

Laramie Trail from Broken Bow Pass to Buckskın Pass

Nevada Path from Frontier Trall to the end of Nevada Path

Oakglen Drive from Manchaca Road to the end of Oakglen Drive
Pawnee Pathway from Roundup Trall to the end of Pawnee Pathway
Perıwınkle Path from Faır Oaks Drıve to Jones Road

Pın Oak Path from Southern Oaks Drıve to Faır Oaks Drıve

Plumas Lane from Fair Oaks Drive to Jones Road

Remuda Trall from Broken Bow Pass to Buckskın Pass
Rım Rock Path from Frontıer Trall to the end of Rım Rock Path
Roundup Trail from Western Tralls Boulevard to Manchaca Road
Sagebrush Circle from Sagebrush Trail to the end of Sagebrush CircleSagebrush Trail from West Gate Boulevard to Western Tralls Boulevard
Southern Oaks Drive from Buffalo Pass to Manchaca Road
Tejas Traıl from Western Tralls Boulevard to Kıowa Pass
Tomahawk Tral from Pack Saddle Pass to the end of Tomahawk TranlVıllage Circle from Buffalo Pass to Village Way DriveVillage Way Court from Village Way Drive to the end of Vıllage Way Court
Village Way Drive from Fairmont Circle to Buffalo Pass
Winding Trail from Jones Road to Choctaw Trail
Woodgreen Cove trom Jones Road to the end of Woodgreen Cove
PART 3. The City Council funds that the prima facie speed limit previously applicable tothe streets, or portions of streets, identified in Parts 1 and 2 of this ordinance isunreasonable or unsafe, and the reduction in speed limit on these streets will reduce thepotential for vehicle-pedestrian accidents

PART 4. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly

PART 5. This ordinance takes effect on November 12, 2007 PASSED AND APPROVED
