Welcome and Visitor Introductions for the September 10 , 2007 meeting were made by AMCPD Chair, Mr. Ron Lucey at 12:05 pm.

Approval of Minutes:

A motion was made by Commissioner Kathy Kasprisin to approve the August 13, 2007 minutes with corrections, and seconded by Commissioner Tanya Winters; the motion was approved unanimously by all.

Presentation 1: Changes to SMART Housing Incentive from 10%-5%

Paul Hilgers, Regina Copic, and Stuart Hersh: City of Austin Neighborhood Housing and City of Austin Neighborhood Development

1. About Smart Housing

- Give builder incentive to make 10% of their housing units accessible
- Committed to affordable housing, need more fee waivers to create more Smart Housing
- Since Inception five years ago, has reviewed 104 sites inspected, however only 3 waivers given.

- Ron: support for changes to SMART Housing, and request statistics on 1 vs. 2 story units.
- Request support of amendment to lower requirement from 10%-5% to increase builder participation.

Presentation 2: Work Base Learning Program

Linda Espy, Deborah Britton, and Thersa Wright: Work Base Learning, Travis County, and Youth Disabilities Coordinator

1. What we do
 - Provide a variety of work based learning opportunities to youth throughout the city; including recruitment, training, and job placement.
 - Requirements: current enrollment and attending school, current school year student id, a social security card, be 14 years of age, and complete 15 hours of job readiness training.
2. This year's highlights
 - 189 recruited for training
 - 150 placed in jobs
 - 130 completed the program
 - 9 were hired by the private sector (HEB, Goodwill, Galaxy Theater) and 50 got school credit .
3. Future goals
 - Increase private sector (CVS, Omni, PACT, Humane Society, Galaxy, Texas Dept. Health.) worksites for part-time summer hiring
 - Help families
 - Assisted living, moving individuals to group homes
 - Help youth become more self sufficient
 - Spend more marketing by word of mouth to increase numbers. Spend more time with individual training as needed.
 - Get good youth feedback. So they want to come back and volunteer
 - Place an emphasis on supervisor training, and giving a personal touch to participants.
3. Budget Challenges
 - Want to recruit 200 youth
 - Minimum Wage went up
 - Travis County increase budget to accommodate 750 participants

Presentation 3: Capital Metro seeking feedback and assistance on purposed plans

Nancy Crowther, and Lemont Ross: Capital Metro Transportation Coordinator and Business and Communication Dept.

1. Implement measure to provide safe pedestrian access to MLK jr. and Crestview Stations for light rail.
 - MLK Jr. Station
 - Activate signal at Alexander Ave. prior to opening of the rail station, to allow drivers to be accustomed to new rail crossing.
 - Crestview Station
 - Shorten pedestrian crossing lengths across Lamar Blvd. to enhance accessibility
 - Simplify the N. Lamar/ Airport Blvd. intersection, to address free right conditions, that allow unprotected pedestrian crossings.
 - Install audible pedestrian signals at intersection adjacent to the Crestview Station
