

ORDINANCE NO. _____

1 **AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE**
2 **PROPERTY LOCATED AT 11701 JOLLYVILLE ROAD FROM SINGLE FAMILY**
3 **RESIDENCE STANDARD LOT (SF-2) DISTRICT TO LIMITED OFFICE-MIXED**
4 **USE-CONDITIONAL OVERLAY (LO-MU-CO) COMBINING DISTRICT.**

6 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

8 **PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to
9 change the base district from single family residence standard lot (SF-2) district to limited
10 office-mixed use-conditional overlay (LO-MU-CO) combining district on the property
11 described in Zoning Case No. C14-2007-0123, on file at the Neighborhood Planning and
12 Zoning Department, as follows:
13

14 Lot 1, Block B, Summit Oaks Subdivision, a subdivision in the City of Austin,
15 Travis County, Texas, according to the map or plat of record in Plat Book 7, Page
16 183, of the Plat Records of Travis County, Texas (the "Property"),
17

18 locally known as 11701 Jollyville Road, in the City of Austin, Travis County, Texas, and
19 generally identified in the map attached as Exhibit "A".
20

21 **PART 2.** The Property within the boundaries of the conditional overlay combining district
22 established by this ordinance is subject to the following conditions:
23

24 A site plan or building permit for the Property may not be approved, released, or
25 issued, if the completed development or uses of the Property, considered cumulatively with
26 all existing or previously authorized development and uses, generate traffic that exceeds
27 2,000 trips per day.
28

29 Except as specifically restricted under this ordinance, the Property may be developed and
30 used in accordance with the regulations established for the limited office (LO) base district,
31 the mixed use (MU) combining district, and other applicable requirements of the City
32 Code.

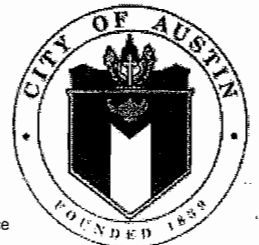
