## AN ORDINANCE VACATING A PORTION OF WEST LIVE OAK STREET.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Council approves vacating the 1200 block of West Live Oak Street, more particularly described in Exhibit A, attached and incorporated as part of this ordinance, to the Housing Authority of the City of Austin to be used for redevelopment of the adjacent Housing Authority of the City of Austin property, subject to a drainage, water and wastewater easement.

PART 2. Murray Legge of LZT Architects on behalf of the Housing Authority of the City of Austin, has posted funds of $\$ 30,621$ (the fair market value of the area being vacated) with the City, to be deposited after approval of this ordinance.

PART 3. The vacation described in Part 1 of the ordinance is contingent upon deposit of the funds, as described in Part 2.

PART 4. This ordinance takes effect on December 10, 2007.

## LEGAL DESCRIPTION

> BEING A 0.837 ACRE ( 36,454 sq ft) PORTION OF THE RIGHT OF WAY OF WEST LIVE OAK STREET DEPICTED ON THE PLAT OF MEADOWBROOK SUBDIVISION, A SUBDIVISION SITUATED IN TRAVIS COUNTY, TEXAS AND RECORDED IN BOOK 87, PAGE 194A-194B, OF THE PLAT RECORDS OF SAID COUNTY, THE MEADOWBROOK SUBDIVISION IS A PLAT OF THAT CERTAIN 19.026 ACRES OUT OF THE ISAAC DECKER LEAGUE IN TRAVIS COUNTY, TEXAS AS CONVEYED TO THE HOUSING AUTHORITY OF THE CITY OF AUSTIN BY DEED OF RECORD IN VOLUME 1169, PAGE 120 OF THE DEED RECORDS OF TRAVIS COUNTY, TEXAS; SAID 0.837 ACRE PORTION OF THE RIGHT OF WAY OF WEST LIVE OAK BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING at a $1 / 2$ " rebar found for the most southeast corner of the Lasner Addition, a subdivision in Travis County, Texas as depicted by the instrument recorded in Book 92, Page 318, of the Plat Records of said county, same being the southwest corner of Lot 1, Block " $A$ " of Section 1 of Southwood, a subdivision in Travis County, Texas, as depicted by the instrument recorded in Book 7, Page 45, of the Plat Records of said county;

THENCE, $\mathrm{N} 30^{\circ} 05^{\prime} 01$ " E, 11172 feet, and $\mathrm{N} 30^{\circ} 06^{\prime} 00^{\prime \prime}$ E (BEARING BASIS for this description), a distance of 784.93 feet to a $1 / 2$ " rebar found in the East r -o-w line of the I . \& G.N Rallroad, same being the most northerly corner of the Lasner Addition, and an angle point in Lot 1 of the said Section 1 of Meadowbrook Subdivision,

THENCE, N $50^{\circ} 21^{\prime} 00^{\prime \prime} \mathrm{E}$, with said railroad r-0-w, and Lot 1 of Section 1 of Meadowbrook, a distance of 5.75 feet to a $1 / 2$ " rebar set at the intersection of the South $r$ -o-w line of West Live Oak Street with the East r-o-w of the I. \& G.N. Railroad, for the northwest corner of Lot 1, of Section 1 of sard Meadowbrook Subdivision, and the southwest comer and PLACE OF BEGINNING of this description;

THENCE, $\mathrm{N} 50^{\circ} 21^{\prime} 00^{\prime \prime} \mathrm{E}$, contmuing with said railroad r-o-w, and with the West r-o-w of West Live Oak Street, a distance of 81.29 feet to a calculated point now inundated by the waters of West Bouldin Creek, said point being at the intersection of the North r-o-w line of West Live Oak Street, and said railroad r-o-w, same beng southwest corner of Lot 2 , of Section 1 of Meadowbrook Subdivision, for the northwest corner hereof, and from which point the calculated northwest corner of Lot 2 of Section 1 of Meadowbrook Subdivision (inundated by the waters of Bouldin Creek - no monument recovered), same being the northwest corner of the above said 19026 acres bears $\mathrm{N} 50^{\circ} 21^{\prime} 00^{\prime}$ " E, 25.37 feet, and from which northwest corner of Lot 2 an "X" found inscribed in an exposed rock on the South bank of Bouldin Creek bears S $25^{\circ} 46^{\prime} 00^{\prime \prime}$ W, 43.09 feet, said inscribed " $X$ " being called for in a deed to the Housing Authority of the City of Austin, in Volume 1169, Page 120, of the Deed Records of Travis County, Texas,

THENCE, along the south line of said Lot 2 and the north r-o-w line of West Live Oak Street, along a curve to the left, which has a radius of 271.93 feet, an arc distance of 5221 feet, the chord of which bears $S 56^{\circ} 56^{\prime} 32^{\prime \prime}$ E, 5213 feet to a cotton gin spindle set;

THENCE, continuing along the south line of said Lot 2 , and the north r-o-w he of West Live Oak Street, S $62^{\circ} 24^{\prime} 21^{\prime \prime}$ E, 387.51 feet to an "X" inscribed this day in a concrete curb for the northeast corner hereof;

THENCE, over and across West Live Oak Street, S $27^{\circ} 35^{\prime} 39^{\prime \prime}$ W, 80.00 feet, to a $1 / 2^{\prime \prime}$ rebar set in the South r-o-w line of West Live Oak Street, same being the North line of the above said Lot 1 , for the southeast corner hereof;

THENCE, along the south r-o-w line, of West Live Oak Street, same being the north line of said Lot $1, \mathrm{~N} 62^{\circ} 24^{\prime} 21^{\prime \prime} \mathrm{W}, 387.51$ feet to a cotton gin spindle set at a point of curvature,

THENCE, along said curve to the right, which has a radius of 35193 feet, and arc distance of 8414 feet, the chord of which bears N $55^{\circ} 33^{\prime} 55^{\prime \prime} \mathrm{W}, 83.94$ feet, to the PLACE OF BEGINNING of the herein described tract, and containing a calculated area of 0.837 acres $(36,454 \mathrm{sq} . \mathrm{ft})$.
