## **PRIOR COUNCIL ACTION:**

Background

Arbors at Creekside Non-Profit Corporation was created by AHFC to carry out the functions of General Partner in the Arbors Housing Partners, Ltd, a partnership that owns the Primrose of Shadow Creek

Austin Inner City Redevelopment Corporation was created by AHFC to carry out the functions of General Partner in the Austin Inner City Redevclopment, Phase 1, Ltd, a partnership that owns the Heritage Heights at Blackshear rental project (SCIP I) Villas on Sixth Non-Profit Corporation was created by AHFC to carry out the functions of General Partner in the Villas on Sixth Housing Associates Limited Partnership, a partnership that owns the Villas on Sixth Apartment complex

In accordance with bylaws of each of the three AHFC related entities listed above, the board of directors of each corporation are appointed by the AHFC board

By this action, the AHFC board appoints Margaret Shaw as director to replace Kelly E Weiss, WHO HAS RESIGNED HER POSITION WITH THE CITY, on each of the three AHFC related non-profit corporations for concurrent terms expiring August 30, 2011
