## ORDINANCE NO. 20071206-008

AN ORDINANCE AMENDING SECTION 13-1-112 OF THE CITY CODE TO REFLECT NAME CHANGES FOR NEW AIRPORT DRIVE; AND PROVIDE FOR EMERGENCY PASSAGE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** The street name for the 9500 through 10300 blocks of New Airport Drive was changed to Hotel Drive in Ordinance No. 20061103-009, and the street name for the 9500 through 10300 blocks of New Airport Drive were changed Freight Lane in Ordinance No. 20061130-010.

## **PART 2.** Section 13-1-112(F) is changed to read:

- (F) The maximum prima facie speed limit is 30 miles per hour at all times on the following streets:
  - (1) Cargo Avenue;
  - (2) Employee Avenue;
  - (3) Freight Lane;
  - (4) [(3)] Golf Course Road from State Highway 71 to 10330 Golf Course Road (City of Austin maintenance administrative offices);
  - (5) [(4)] Hotel Drive [New Airport Drive;]
  - (6) [(5)] Presidential Boulevard entrance ramp (New Airport Drive to 2800 Presidential Boulevard);
  - (7) [(6)] Presidential Boulevard from 3325 to 3513 (upper level) and from 3325 to 3509 (lower level);
  - (8) [(7)] Presidential Boulevard upper and lower levels (3705 and 3701 Presidential Boulevard respectively) to surface parking lot exit (South Plaza 3821 Presidential Boulevard);
  - (9) [(8)] Presidential Boulevard return loop running between outbound and inbound lanes (4019 to 2801 respectively);
  - (10) [(9)] Presidential Boulevard exit ramp (3115 Presidential Boulevard);

(11) [(10)] Presidential Boulevard exit ramp (4010 Presidential to New Airport Drive);
(12) [(11)] Rental Car Lane;
(13) [(12)] Service Avenue; and
(14) [(13)] Spirit of Texas Drive.

PART 3. The Council finds that because changes to Austin-Bergstrom International Airport official street names were not also adopted in the City's speed limit regulations, this inconsistent use of street names in the speed limit regulations may affect the enforceability of certain speed limits at the airport, and this constitutes an emergency. Because of the emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.
