THURSDAY, DECEMBER 13, 2007

Invocation: Brandon Washington, Systems Support Technician, CTM

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, December 13, 2007 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Wynn called the Council Meeting to order at 10:21 a.m.

The Mayor asked Council Members to report on upcoming agenda items:

Mayor Pro Tem Dunkerley requested staff bring an ordinance to require a permit for certain construction activities to take place downtown during the night or early in the morning to avoid traffic congestion.

Council Member McCracken announced that the Land Use Transportation Committee will bring an item in February to help the City achieve its 25% affordable housing goal in the Transportation Oriented Districts.

Council Member Kim announced she will be working with the Downtown Austin Alliance to create a pilot program to install traffic signals in the downtown crosswalks that count down the time left to cross the intersection to protect the pedestrians.

Council Member Kim announced she will be working with the Small Business Development office to create a program to help small businesses open up an additional location if they so desire and encourage small businesses to stay in Austin.

Council Member Leffingwell announced he will conduct a meeting in late January with four more meetings to follow to receive citizen input on the online open government initiative to make government more accessible and available.

CONSENT AGENDA

The following items were acted on by one motion. No separate discussion or action occurred on any of the items. The consent items were approved on Council Member McCracken's motion, Council Member Kim's second on a 7-0 vote.

1. Approval of the minutes of the Austin City Council from the regularly scheduled meeting of December 6, 2007.
The minutes from the meeting of December 6, 2007 were approved.

2. Approve a contract with PennWell Corporation, Tulsa, OK, for Austin Energy to serve as Host Utility for the 2010 POWER-GEN Renewable Energy & Fuels Conference and Tradeshow on March 2-4, 2010, in an amount not to exceed \$60,000. Funding is available in the Fiscal Year 2007-2008 Operating Budget of Austin Energy.
The motion authorizing a contract with PennWell Corporation was approved.
3. Approve an Ordinance amending Ordinance 20070910-003, the Fiscal Year 2007-2008 Operating Budget of Austin Energy by accepting and appropriating Program Income donated by Clean Cities participants in the amount of \$40,000 for administration of the Central Texas Clean Cities Program for a total program income of \$84,000. Funding is available from Clean Cities participants. Recommended by the Electric Utility Commission.
Ordinance No. 20071213-003 was approved.
4. Approve issuance of a rebate in the amount of \$66,218.25 to Lifetime Fitness Center for the installation of high efficiency air conditioning and lighting equipment, and a reflective roof coating for their location at 7101 South MoPac Expressway in Austin, TX. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Conservation Rebates and Incentive Budget of Austin Energy. Recommended by the Resource Management Commission.
The motion authorizing the issuance of a rebate to Lifetime Fitness Center was approved.
5. Approve issuance of a rebate in the amount of \$104,757.10 to Target Super Stores for the installation of high efficiency air conditioning, lighting equipment and controls, and a reflective roof coating at 9500 South IH-35 #G, Austin, TX. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Conservation Rebates and Incentive Budget of Austin Energy. Recommended by the Resource Management Commission.
The motion authorizing the issuance of a rebate to Target Super Stores was approved.
6. Approve an ordinance amending the Fiscal Year 2007-2008 Austin Water Utility Operating Budget Wildlife Conservation Fund of Ordinance No. 20070910-003 to increase the beginning balance by \$727,065 for a total beginning balance of \$4,350,760, increase expenditures for Capital Outlay by \$500,000 for total expenditures of \$3,500,000, and increase the ending balance by \$227,065 for a total ending balance of \$1,200,760; and appropriating \$500,000 to the Balcones Canyonlands Conservation Plan for land acquisition. Funding in the amount of \$500,000 is available in the Fiscal Year 2007-2008 Operating Budget of Balcones Canyonlands Conservation Plan Fund.
Ordinance No. 20071213-006 was approved.
7. Authorize the City Manager to negotiate and execute an agreement with the City of Round Rock, Leander and Cedar Park to share in the costs of evaluating the Brushy Creek Regional Wastewater System. Funding in the amount of \$30,000 is available in the Fiscal Year 2007-2008 Operating Budget of the Austin Water Utility. Recommended by the Water and Wastewater Commission.
The motion authorizing the City Manager to negotiate and execute an agreement with the City of Round Rock, Leander and Cedar Park was approved.

Items 8 through 13 were pulled for discussion.

14. Authorize the City Clerk to negotiate and execute an agreement with Travis County for the City's use of Travis County's voting equipment and for the County Clerk to administer the City's elections. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Office of the City Clerk.
The motion authorizing the City Clerk to negotiate and execute an agreement with Travis County was approved.

15. Approve an ordinance changing the name Mala Suerte Drive to Buena Suerte Drive. The Application fee of \$400 has been received. The processing fee of \$500 has been determined for two street signs located at the corners of Mala Suerte Drive and Twilight Shadow Drive and Mala Suerte Drive and Via Correto Drive.
Ordinance No. 20071213-015 was approved.
16. Adopt a resolution approving the 2008 inductees to the Austin Music Memorial. Recommended by the Austin Music Commission.
Resolution No. 20071213-016 was approved.
17. Authorize execution of a 12-month Economic Development Agreement with ATI-BIOSCIENCE, a division of the Austin Technology Incubator, a project of the University of Texas-Austin, in an amount not to exceed \$125,000, to provide strategic business consulting services to local bio-technology startups to foster economic development and job creation. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Financial and Administrative Services Department.
The motion authorizing the execution of an economic development agreement with ATI-Bioscience was approved.
18. Authorize execution of a 12-month Economic Development Agreement with ATI-WIRELESS, a division of the Austin Technology Incubator, a project of the University of Texas-Austin, in an amount not to exceed \$200,000, to provide strategic business consulting services to Austin high technology startups to foster economic development and job creation. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Financial and Administrative Services Department.
The motion authorizing the execution of an economic development agreement with ATI-Wireless was approved.
19. Approve negotiation and execution of a federal representation services contract with BARBARA MCCALL and ASSOCIATES, Washington, D.C., in an amount not to exceed \$75,000. Funding is available in the Fiscal Year 2007-2008 Operating Budgets of the Government Relations Office.
The motion authorizing the negotiation and execution of a federal representation services contract with Barbara McCall and Associates was approved.
20. Approve execution of the third 12-month renewals between the City and eight social service agencies (one agency has two contracts) for a total not-to-exceed amount of \$2,194,071 for Fiscal Year 2007-2008, with three 12-month renewal options, in a total not-to-exceed contract amount of \$8,776,284. Attachment A sets forth the names of the contractors and the funds authorized for each. Funding in the amount of \$1,645,554 is available in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department. The term of each contract is for the period of January 1, 2008 through December 31, 2008. Funding for the balance of the contracts and renewal options is contingent on available funding in future budgets
The motion authorizing the execution of the third renewals between the City and eight social service agencies was approved.
21. Approve execution of 12-month contracts between the City and 35 social service agencies at a total not to exceed of \$4,910,886. Funding in the amount of \$3,594,938 is available in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department; Fiscal Year 2007-2008 Approved Certification funds totaling \$117, 639 are included. The term of each contract is for the period of January 1, 2008 through December 31, 2008. Funding for the balance of each contract is contingent on available funding in a future budget.

The motion authorizing the execution of contracts between the City and 35 social service agencies was approved.

22. Approve execution of a 12-month contract between the City and AMERICAN YOUTHWORKS, Austin, TX for January 1-December 31, 2008 to provide workforce development services for a not-to-exceed amount of \$464,248. Funding in the amount of \$201,374 is available in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department; Funding in the amount \$60,000 is available in the Fiscal Year 2007-2008 Operating Budget of the Parks and Recreation Department; Funding in the amount of \$50,000 is available in the Fiscal Year 2007-2008 Capital Improvement Program (CIP) Budget of the Parks and Recreation Department; Funding in the amount of \$60,750 is available in the Fiscal Year 2007-2008 Operating Budget of the Austin Water Utility; and Funding in the amount of \$25,000 is available in the Fiscal Year 2007-2008 CIP Budget of the Watershed Protection and Development Review Department. The term of the contract is for the period of January 1, 2008 through December 31, 2008. Funding for the balance of this contract is contingent on available funding in future budgets.

The motion authorizing the execution of a contract between the City and American Youthworks was approved.

23. Approve execution of the 12-month contract renewal option between the City and CAPITAL IDEA, Austin, TX, from January 1-December 31, 2008, to provide workforce development services for an amount not to exceed \$1,049,370. Funding in the amount of \$787,028 is available in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department. The term of the contract is for the period of January 1, 2008 through December 31, 2008. Funding for the remaining three months of the contract is contingent on available funding in a future budget.

The motion authorizing the execution of the contract renewal option between the City and Capital Idea was approved.

24. Approve execution of a 12-month Contract Amendment No. 5 with the CENTER FOR CHILD PROTECTION, Austin, TX to provide child protection services from January 1-December 31, 2008, adding \$144,104 to the contract amount as allocated by Council for Fiscal Year 2007-2008, for a total not-to-exceed contract amount of \$261,370 and to authorize inclusion of the 3.5 percent increase approved for Fiscal Year 2007-2008, as well as an increase of \$144,104 to the contract amount for the each of the three remaining 12-month extension options, for a total not-to-exceed amount of \$261,370 for each extension option. Funding in the amount of \$196,028 is included in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department. The term of the contract is for the period of January 1, 2008 through December 31, 2008. Funding for the balance of this contract is contingent on available funding in future budgets.

The motion authorizing the execution of a contract amendment number 5 with the Center for Child Protection was approved.

25. Approve execution of a 12-month contract with COMMUNITIES IN SCHOOLS-CENTRAL TEXAS, INC., Austin, TX for youth services in an amount not to exceed \$291,754. Funding in the amount of \$218,816 is available in the Fiscal Year 2007-2008 Operating Budget of the Health and Human Services Department. The term of the contract is for the period January 1, 2008 through December 31, 2008. Funding for the balance of this contract is contingent on available funding in a future budget.

The motion authorizing the execution of a contract with Communities In Schools-Central Texas, Inc. was approved.

26. Approve execution of a 12-month amendment to and extension of the Interlocal Agreement between the City and AUSTIN/TRAVIS COUNTY MENTAL HEALTH MENTAL RETARDATION CENTER, Austin, TX for provision of mental health and mental retardation services from January 1-December 31,

2008, in the total not-to-exceed amount \$1,624,310, with one remaining 12-month extension option in the total not-to-exceed amount of \$1,624,310. Funding in the amount of \$1,218,233 is included in the Fiscal Year 2007-2008 Operating Budget for the Health and Human Services Department. The contract period will be January 1, 2008 through December 31, 2008. Funding for the balance of the agreement and the remaining extension option is contingent on available funding in future budgets.

The motion authorizing the execution of an amendment to and extension of the interlocal agreement between the City and Austin/Travis County Mental Health Mental Retardation Center was approved.

27. Approve payment of membership fees to the Austin-San Antonio Corridor Council, in an amount not to exceed \$50,000. Funding is available in the 2007-2008 Operating Budget of the Neighborhood Planning and Zoning Department.
The motion authorizing the payment of membership fees to the Austin-San Antonio Corridor Council was approved.
28. Approve an ordinance adopting the Coshena III and IV Annexation and Development Agreement, concerning annexation and development of the Coshena Tracts (approximately 10 acres in Travis County west of the intersection of IH 35 North and Grand Avenue Parkway), providing for a 10 year delay of annexation. Funding necessary to provide general governmental services to this tract is available in the budgets of the departments which will be providing the services.
This item was postponed to February 14, 2008.
29. Approve second/third readings of an ordinance to annex the Grand Avenue Parkway annexation area for full purposes (approximately 556 acres in Travis County at the intersection of IH 35 North and Grand Avenue Parkway) and waive zoning application fees for property within the annexed area for a period of one year from the effective date of annexation. Funding necessary to provide general governmental services to this tract is available in the budgets of the departments which will be providing the services.
This item was postponed to February 14, 2008.
30. Approve a resolution authorizing execution of a First Amendment to the 1985 Interlocal Agreement between the City and the City of Bastrop Regarding Planning Issues and the Regulation of Subdivisions in the Extra Territorial Jurisdiction.
Resolution No. 20071213-030 was approved.
31. Approve second/third readings of an ordinance to annex the River Hills Road area for the limited purposes of planning and zoning (Approximately 2 acres in Travis County located east of River Hills Road approximately 400 feet north of the intersection of River Hills Road and Taylor Road). Limited purpose annexation does not have a significant impact on the general fund.
This item was withdrawn.
32. Approve second/third readings of an ordinance approving a regulatory plan for the River Hills Road area, which is being annexed for limited purposes. Limited purpose annexation does not have a significant impact on the general fund.
This item was withdrawn.
33. Approve an ordinance authorizing the acceptance of \$91,500 in grant funds from the Greater Austin Crime Commission; and amending the Fiscal Year 2007-2008 Police Department Operating Special Revenue Fund of Ordinance No. 20070910-003 to appropriate \$91,500 for the Austin Police Department Badge Replacement Program to purchase newly designed badges for Austin Police Department sworn officers. This funding was provided to the Commission by former Austin Mayor Roy Butler. The funding is being granted to the City of Austin from the Greater Austin Crime Commission on behalf of Mayor

Butler to be used exclusively for the purchase of new badges for sworn personnel of the Austin Police Department.

Ordinance No. 20071213-033 was approved.

34. Approve a resolution authorizing the fee simple acquisition of Lot 12, Block N, Onion Creek Forest, Section 2, Amended Plat, a subdivision in Travis County, Texas, located at 5705 Vine Hill Drive, from Martin and Christine Guajardo for the Onion Creek Voluntary Flood Buyout-FEMA-1606-DR Project, in the amount of \$62,000 for the land and improvements, plus moving related expenses not to exceed \$10,000, for a total not to exceed \$72,000. Funding is available in the Fiscal Year 2007-2008 Capital Budget of the Watershed Protection and Development Review Department.
Resolution No. 20071213-034 was approved.

35. Approve a resolution authorizing the fee simple acquisition of Lot 5, Block J, Onion Creek Forest, Section 2, Amended Plat, a subdivision in Travis County, Texas, located at 6903 Onion Crossing Drive, from The Estate of Robert C. Maldonado and Jesusa J. Maldonado, deceased for the Onion Creek Voluntary Flood Buyout-FEMA-1606-DR Project, in the amount of \$60,000 for the land and improvements and \$69,900 in owner assisted relocation benefits, plus moving related expenses not to exceed \$10,000, for a total not to exceed \$139,900. Funding is available in the Fiscal Year 2007-2008 Capital Budget of the Watershed Protection and Development Review Department.

Bowman, individually and as Trustee of the Powers Lewis Bowman Children's Trusts, (iii) Molly Bowman Stephens, Individually and as Trustee of the Molly Bowman Stephens Children's Trusts, (iv) VGWW Land No. 5, L.L.C, (v) DWDTHD land No. 5, L.L.C, and (vi) DWDTHD land No. 1, L.L. C, (vii) VGWW Land No. 1 L.L.C, in an amount not to exceed \$2,919,800. Funding is available in the Fiscal Year 2007-2008 Operating Budget of the Balcones Canyonlands Conservation Plan (BCCP), Austin Water Utility.

40. Approve a resolution authorizing the sale of a Raw Water Intake Easement and Temporary Construction Easement to the Lower Colorado River Authority (LCRA). The water intake easement is a 0.116-acre tract of land in Lake Austin adjacent to the LCRA's existing water intake and waterline. The 18-month Temporary Construction Easement is a 0.417-acre tract of land in Lake Austin adjacent to the proposed Water Intake Easement. The LCRA has agreed to purchase the easements from the City of Austin for the total appraised value of \$2,300.

Resolution No. 20071213-040 was approved.

41. Authorize execution of a construction contract with CASH CONSTRUCTION COMPANY, LTD., Pflugerville, TX, for West Bouldin Creek Phase B in the amount of \$2,375,547.70 plus an \$118,777.30 contingency, for a total contract amount not to exceed \$2,494,325. Funding is available in the Fiscal Year 2007-2008 Capital Budget of the Austin Water Utility. Lowest bid of 3 bids received. This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) by meeting the goals with 10.19 % MBE and 3.01% WBE subcontractor participation. Presented to the Water and Wastewater Commission.

The motion authorizing the execution of a construction contract with Cash Construction Company, Ltd. was approved.

42. Approve an ordinance amending Section 12-4-64(D) of the City Code to add a portion of Colony Loop to the list of streets having a maximum speed limit of 20 miles per hour during certain times for students attending Overton Elementary School; and provide for emergency passage. Funding in the amount of \$400 for the installation of signs available in the 2007-2008 Child Safety Fund of the Public Works Department.

Ordinance No. 20071213-042 was approved.

43. Approve an ordinance to amend Section 12-4-64(D) of the City Code to add a portion of South Pleasant Valley Road to the list of streets having a maximum speed limit of 20 miles per hour during certain times for students attending Perez Elementary School; and provide for emergency passage. Funding in the amount of \$400 for the installation of signs available in the 2007-2008 Child Safety Fund of the Public Works Department.

Ordinance No. 20071213-043 was approved.

44. Approve an ordinance amending Section 12-4-64(D) of the City Code to add a portion of Salina Street to the list of streets having a maximum speed limit of 20 miles per hour during certain times for students attending Kealing Middle School; and provide for emergency passage. Funding in the amount of \$400 for the installation of signs is available in the Fiscal Year 2007-2008 Child Safety Fund of the Public Works Department.

Ordinance No. 20071213-044 was approved.

45. Approve an ordinance amending Section 12-4-64(D) of the City Code to add a portion of West 34th Street to the list of streets having a maximum speed of 25 miles per hour. Funding in the amount of \$400 is available in the Fiscal Year 2007-2008 Operating Budget of the Public Works Department for the installation of necessary signs.

Ordinance No. 20071213-045 was approved.

46. Authorize execution of a 24-month interlocal agreement with the THE UNIVERSITY OF TEXAS, Austin, TX, on behalf of Clean Energy Incubator, a program of the Austin Technology Incubator for mutual assistance in the clean energy field in an amount not to exceed \$415,000 in the first year, and an amount not to exceed \$415,000 in the second year, for a total amount not to exceed \$830,000. Funding in the amount of \$415,000 is available in the Fiscal Year 2007-2008 Operating Budget of Austin Energy. Funding for the second year is contingent upon available funding in future budgets. Interlocal Agreement This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority -Owned and Women-Owned Business Enterprise Procurement Program).). This contract is an Interlocal Agreement; therefore, it is exempted under Chapter 791 of the Texas Government Code and no goals were established for this solicitation. No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.
The motion authorizing the execution of an interlocal agreement with the The University of Texas was approved.
47. Authorize award, negotiation, and execution of Amendment No. 6 to the requirements service contract with ALLIANCE DATA SYSTEMS, Dallas, TX, for a 24-month extension of maintenance and support services for the utility customer information system in an estimated amount not to exceed \$15,500,000, for a revised total estimated contract amount not to exceed \$82,934,442. Funding is contingent upon available funding in future budgets. Contract Amendment. This purchase will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.
The motion authorizing the award, negotiation and execution of amendment number 6 to the requirements service contract with Alliance Data Systems was approved.
48. Authorize award and execution of a 24-month requirements supply agreement with HILL COUNTRY ELECTRIC SUPPLY, Austin, TX to provide electrical repair parts for Square D manufactured equipment for the Austin Water Utility, in an estimated amount not to exceed \$150,000, with two 12-month extension options in an estimated amount not to exceed \$75,000 per extension option, for a total estimated contract amount not to exceed \$300,000. Funding in the amount of \$62,500 is available in the Fiscal Year 2007-2008 Operating Budget of the Austin Water Utility. Funding for the remaining 14 months of the original contract period and extension options is contingent upon available funding in future budgets. Authorize award and execution of a contract through the HOUSTON-GALVESTON AREA COUNCIL OF GOVERNMENTS (H-GAC) with CALDWELL COUNTRY CHEVROLET, Caldwell, TX, for the purchase of 51 light duty vehicles in an amount not to exceed \$1,476,899. Funding in the amount of \$368,122 is available in the Fiscal Year 2007-2008 Operating Budget of the Financial and Administrative Services Department Vehicle Acquisition Fund. Funding in the amount of \$165,642 is available in the Fiscal Year 2007-2008 Operating Budget of the Aviation Department. Funding in the amount of \$35,191 is available in the Fiscal Year 2007-2008 Operating Budget of the Public Safety & Emergency Management Department.
