



RECOMMENDS AUTHORIZATION TO AWARD AND EXECUTE A 24-MONTH REQUIREMENTS SUPPLY CONTRACT WITH MUNICIPAL WATER WORKS SUPPLY, L. P., ROYCE CITY, TX FOR THE SUPPLY OF MANHOLE RINGS AND COVERS FOR THE AUSTIN WATER UTILITY IN AN ESTIMATED AMOUNT NOT TO EXCEED \$127,930, WITH TWO 12-MONTH EXTENSION OPTIONS IN ESTIMATED AMOUNTS NOT TO EXCEED \$70,362 FOR THE FIRST EXTENSION OPTIONS AND \$80,916 FOR THE SECOND EXTENSION OPTION, FOR A TOTAL ESTIMATED CONTRACT AMOUNT NOT TO EXCEED \$279,208.

The Water and Wastewater Commission recommends authorization to award and execute a 24-month requirements supply contract with **MUNICIPAL WATER WORKS SUPPLY, L. P.**, Royce City, TX for the supply of manhole rings and **covers** for the Austin Water Utility in an estimated amount not to exceed \$127,930, with two 12-month extension options in estimated amounts not to exceed \$70,362 for the first extension options and \$80,916 for the second extension option, for a total estimated contract amount not to exceed \$279,208.
