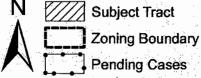

#### STAFF RECOMMENDATION

The staff recommendation is to LO-CO, Limited Office-Conditional Overlay District, zoning. The conditional overlay will limit the development intensity for the entire site to less than 2,000 vehicle trips per day.

In addition, if the requested zoning is granted, the staff also recommends that 57 feet of right-of-way should be dedicated from the existing centerline of Anderson Mill Road in accordance with the Transportation Plan. [LDC, Sec. 25-6-51 and 25-6-55)

## BASIS FOR RECOMMENDATION

1. The proposed zoning should be consistent with the purpose statement of the district sought.

Limited office (LO) district is the designation for an office use that serves neighborhood or community needs and that is located in or adjacent to residential neighborhoods. An office in an LO district may contain one or more different uses. Site development regulations and performance standards applicable to an LO district use are designed to ensure that the use is compatible and complementary in scale and appearance with the residential environment.

2. The proposed zoning should promote consistency and orderly planning.

The proposed zoning will promote consistency and orderly planning because it will create a transition is allowable uses from the existing service station and funeral home uses to the south fronting Anderson Mill Road to the single-family residential neighborhood to the north.

The staff recommends LO zoning for this site because this zoning district will allow for low intensity office and commercial uses that will serve the surrounding residential areas.

In addition, Limited Office zoning is suitable for this site because it will allow for a transition in the intensity of commercial uses to office uses along Anderson Mill Road to the west away from U.S. Highway 183 North.

3. The proposed zoning should allow for a reasonable use of the property.

The LO-CO zoning district would allow for a fair and reasonable use of the site. LO zoning is appropriate for this tract of land because it will permit the development of a day care facility adjacent to existing residential uses (SF-2 zoning) to the north.

## **EXISTING CONDITIONS**

#### **Site Characteristics**

The property in question is a grassy, moderately vegetated tract of land. To the north, there are single-family residential uses. To the east there is a retail shopping center fronting U. S. Highway 183. The land to the south is developed with a funeral home. The property to the west consists of and undeveloped tract of land and a service station use.

#### **Hill Country Roadway**

The site is not within a Hill Country Roadway Corridor.

### **Impervious Cover**

The maximum impervious cover allowed by the GR zoning district would be 90 %. However, because the Watershed impervious cover is more restrictive than the GR zoning district's allowable impervious cover, the impervious cover on this site would be limited by the watershed ordinance.

Under current watershed regulations, development or redevelopment on this site will be subject to the following impervious cover limits:

#### **Environmental**

The site is located over the North Edward's Aquifer Recharge Zone. This site lies over the divide between the Walnut Creek and Bull Creek Watersheds, which are classified as Suburban and Water Supply Suburban watersheds, respectively, by Chapter 25-8 of the City's Land Development Code. These distinct watersheds respectively fall into the Desired Development Zone and Drinking Water Protection Zone.

According to flood plain maps, there is no floodplain within, or adjacent to the project boundary.

Standard landscaping and tree protection will be required in accordance with LDC 25-2 and 25-8 for all development and/or redevelopment.

At this time, site specific information is unavailable regarding existing trees and other vegetation, areas of steep slope, or other environmental features such as bluffs, springs, canyon rimrock, caves, sinkholes, and wetlands.

Under current watershed regulations, development or redevelopment on this site will be subject to the following water quality control requirements:

 Structural controls: Sedimentation and filtration basins with increased capture volume and 2 year detention.

At this time, no information has been provided as to whether this property has any pre-existing approvals that preempt current water quality or Code requirements.

The site is located within the endangered species survey area and must comply with the requirements of Chapter 25-8: Endangered Species in conjunction with subdivision and/or site plan process.

## **Transportation**

The Austin Metropolitan Area Transportation Plan calls for a total of 114 feet of right-of-way for Anderson Mill Road. If the requested zoning is granted, then 57 feet of right-of-way should be dedicated from the existing centerline of Anderson Mill Road in accordance with the Transportation Plan. [LDC, Sec. 25-6-51 and 25-6-55)

A traffic impact analysis was waived for this case because the applicant agreed to limit the intensity and uses for this development. If the zoning is granted, development should be limited through a conditional overlay to less than 2,000 vehicle trips per day. [LDC, 25-6-117]

#### Water and Wastewater

The landowner intends to serve the site with City of Austin water and wastewater utilities. The landowner, at own expense, will be responsible for providing the water and wastewater utility improvements, offsite main extensions, system upgrades, utility relocation, and or abandonment. The water and wastewater plan must be in accordance with the City of Austin utility design criteria. The water and wastewater utility plan must be reviewed and approved by the Austin Water Utility. All water and wastewater construction must be inspected by the City of Austin. The landowner must pay the City inspection fee with the utility construction. The landowner must pay the tap and impact fee once the landowner makes an application for a City of Austin water and wastewater utility tap permit.

## **Stormwater Detention**

At the time a final subdivision plat, subdivision construction plans, or site plan is submitted, the developer must demonstrate that the proposed development will not result in additional identifiable flooding of other property. Any increase in stormwater runoff will be mitigated through on-site stormwater detention ponds, or participation in the City of Austin Regional Stormwater Management Program, if available.

#### Compatibility Standards

This site will be subject to commercial design standards. Anderson Mill Road is the principle street and is classified as suburban roadway.

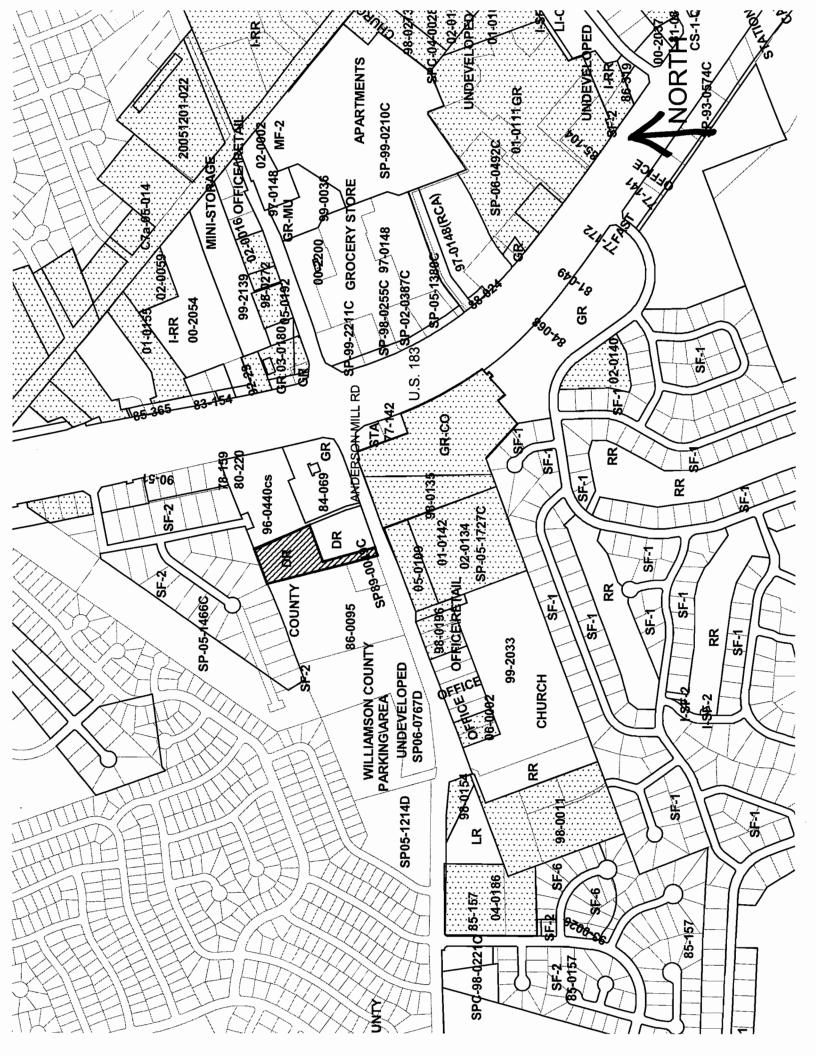
The site is subject to compatibility standards. Along the North property line, the following standards apply:

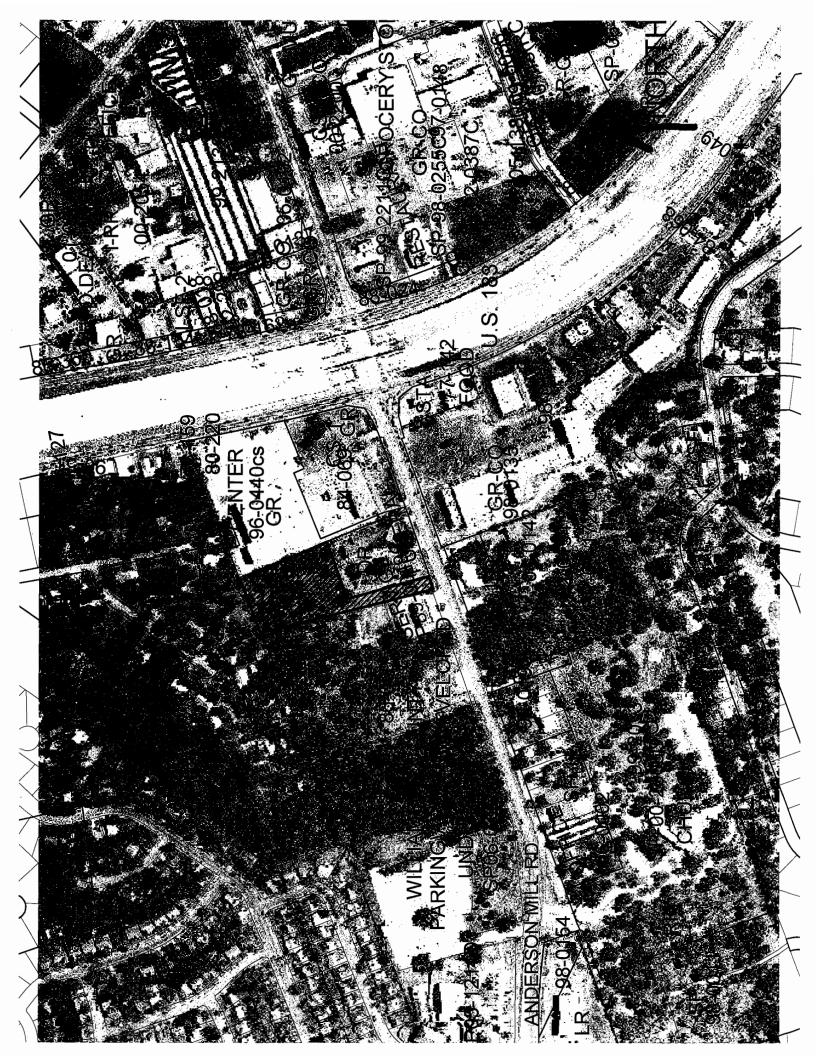
- No structure may be built within 25 feet of the property line.
- No structure in excess of two stories or 30 feet in height may be constructed within 50 feet of the property line.

- No structure in excess of three stories or 40 feet in height may be constructed within 100 feet of the property line.
- No parking or driveways are allowed within 25 feet of the property line.
- A landscape area at least \_\_\_\_ feet wide is required along the property line. In addition, a fence, berm, or dense vegetation must be provided to screen adjoining properties from views of parking, mechanical equipment, storage, and refuse collection.

Additional design regulations will be enforced at the time a site plan is submitted.

The site must comply with the ordinance requirements for compatibility standards or receive a waiver from the Land Use Commission. Any waivers of required setbacks to less than five feet will require Board of Adjustment approval. [Section 25-2-1081].

- 2. A ten foot (10') sound retarding fence shall be constructed along the north property line adjacent to the single family residential property. Special care shall be taken to preserve large diameter trees along said property line.

  3. A foot (6) sound retarding fence shall be constructed along the side property lines for a minimum distance of 150 feet.
- 4. Additional meetings will be scheduled, at your convenience, to review the site plan and discuss the detention and water quality facilities proposed for the site.

Dear Ms. Sirwaitis

I just heard about a new day care center planned for Anderson Mill road near Hwy 183, and that you are voting on it this month. I want you to know that I definitely support the need for a new daycare center...there are tons of kids in the nearby neighborhoods, and it's hard to find openings.

BUT...please make sure that something is done to address the DANGEROUS stopping and turns that will be necessary to come and go from the location. Anderson Mill is the main cut through from 620 to 183. There are no turn lanes in this section of the road, traffic is very heavy, and vehicles move FAST. If the entry is going to be where the developer's sign is, it's right over a rise in the road and visibility is bad. Almost all of the residential neighborhoods that will use a new daycare at this location are west of the site, which means they have to turn left across two lanes of traffic to drop kids off in the morning. Most of the people then need to go on towards Hwy 183 to get to work, so then it will be really crazy... they will have to turn left across two lanes of traffic, into VERY HEAVY inbound morning traffic, to get to 183.

At the least, they have to put in a center turn lane here. Better yet would be a traffic light. If you didn't live out here, you may not get this (the developer probably doesn't even know how bad it is), but ask anyone who drives this route and they will tell you it would be a daily risk to kids and Moms to pull in and out of there.

Please make sure that you make this part of the plans for the daycare.

Dear Mr. Mayor and Ms. Sirwaitis and Ms. Jain

I heard from my neighbors yesterday about the new day care center going in at 9700 Anderson Mill. We all agreed that more daycare space is good for this area, but something needs to be done about the danger situation there before a day care gets built on that side of the road. The old daycare used to be across the street from this, so it was easy for people coming in towards 183 to drop off kids and get right back into traffic. This new location means that people will have to stop in the middle of Anderson Mill Road (with no turn lane) and turn across oncoming traffic to get in there. Then to leave and get to 183 you'll have to try to pull out across two lanes of fast traffic (it's 45 through there) and get into the huge traffic coming down Anderson Mill (its also 45, but people go 50 – 55 because they're coming down the hill), which is impossible in the morning. If you donut believe me, come out here in the morning and try pulling into the Valero station (right next to where the daycare is going to go). You cant get back out unless you turn right, go a half mile back up the road to the traffic signal, turn in by the elementary school, and then make a U-turn in front of the school (dangerous) and then come back down Anderson Mill.

I saw on your website that a traffic impact analysis is waived but that's wrong because they need to extend the turn lane in front of there if they're going to build the daycare. Right now, it stops at the funeral home. The county says that someday the whole road will expand through here just like they have done everywhere else along Anderson Mill except right here, but they donut have any money or any plan to do it. We want the daycare, but people will sign up and they wont know how dangerous this is until they start going and they wont really be able to stop going because there aren't enough other daycare places around here, so they're just going to try to make these turns every morning and SOMEONE IS GOING TO GET HURT or worse.

They need to connect the daycare to Valero and put a stop light in at Valero which is also across from the shopping center which is where everyone wants to turn anyway, then you could get to the daycare, the gas station and the shopping center all without risking your neck every day.

You need to come see what I'm talking about before you finish this plan. It says that the assigned staff for NPZ transportation approved it but I can't believe they actually saw this in the morning and think it could be safe the way it is.
