

**ORDINANCE NO.**

**AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS BOUNDED BY HANCOCK DRIVE, SHOAL CREEK PROPER, LOOP 1 (MOPAC EXPRESSWAY) (NORTH) EAST FRONTAGE ROAD, AND WEST 45<sup>TH</sup> STREET; AND CORRECTING AN ERROR IN ORDINANCE NO. 20080117-010.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

Highland Terrace from Perry Lane to 45<sup>th</sup> Street (West) Ramp.

**PART 2.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

48<sup>th</sup> Street (West) from Chiappero Trail to Finley Drive.

49<sup>th</sup> Street (West) from Bull Creek Road to Strass Drive.

49<sup>th</sup> ½ Street (West) from Strass Drive to Bull Creek Road.

50<sup>th</sup> Street (West) from Bull Creek Road to Westfield Drive.

Chiappero Trail from 45<sup>th</sup> Street (West) to 48<sup>th</sup> Street (West).

Finley Drive from 45<sup>th</sup> Street (West) to Hancock Drive.

Fiset Drive from Strass Drive to Finley Drive.

Fresco Drive (North) from Hancock Drive to Fresco Drive (West).

Fresco Drive (West) from Fresco Drive (North) to Bull Creek Road.

La Ronde Street from Chiappero Trail to the end of La Ronde Street.

Oakmont Boulevard from 45<sup>th</sup> Street (West) to 48<sup>th</sup> Street (West).

Pembroke Trail from Rue Street to Strass Drive.

Perry Lane from Loop 1 (MoPac Expressway) (North) East Frontage Road to Bull Creek Road.

Placid Place from 45<sup>th</sup> Street (West) to Hancock Drive.

Rue Street from Pembroke Trail to 49<sup>th</sup> Street (West).

Strass Drive from Pembroke Trail to Hancock Drive.

Terrain Lane from Placid Place to Highland Terrace.

Village Drive from Placid Place to Westfield Drive.

Westfield Drive from Village Drive to the end of Westfield Drive.

West Frances Place from Village Drive to Hancock Drive.

West Market Drive from Placid Place to Fresco Drive (West).

West Park Drive from Village Drive to Hancock Drive.

Winston Court from Bull Creek Road to the end of Winston Court.

**PART 3.** The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Parts 1 and 2 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.

**PART 4.** Ordinance No. 20080117-010 is amended to read:

**PART 1.** Section 12-4-64(D) (*Table of Speed Limits*) is amended to add the following street section to the list of streets with a maximum speed of 25 [20] miles per hour during certain times in a school zone:

Huntland Drive from 450 feet west of Twin Crest Drive to 300 feet east of Twin Crest Drive (Saint Francis School).

**PART 5.** The amendments made in this ordinance shall be incorporated in alphabetical order in Section 12-4-64(D) (*Table of Speed Limits*).

**PART 6.** This ordinance takes effect on \_\_\_\_\_, 2008.
