

**ORDINANCE NO.**

1 **AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO**  
2 **ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON**  
3 **CERTAIN STREETS BOUNDED BY I.H. 35 (NORTH) EAST FRONTAGE ROAD**  
4 **TO THE WEST, AIRPORT BOULEVARD TO THE SOUTH, ROWOOD ROAD**  
5 **TO THE EAST AND NORWOOD ROAD TO THE NORTH; AND THE AREA**  
6 **BOUNDED BY DECKER LANE TO THE EAST, LOYOLA LANE TO THE**  
7 **SOUTH, VALLEYFIELD DRIVE TO THE WEST, AND MAYVIEW DRIVE TO**  
8 **THE NORTH.**

10 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

11  
12 **PART 1.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to  
13 read:

14 Parkwood Road from Airport Boulevard to Norwood Road [~~the end of Parkwood~~  
15 ~~Road~~].

16  
17 **PART 2.** Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to  
18 add the following street sections with 25 mile per hour speed limits:

19 **Area 16:**

20 Bentwood Road from I.H. 35 (North) East Frontage Road to Rowood Road.

21 Elwood Road from Fernwood Road to Norwood Road.

22 Fairwood Road from Elwood Road to Rowood Road.

23 Fernwood Road from I.H. 35 (North) East Frontage Road to Parkwood Road.

24 Norwood Road from Elwood Road to Parkwood Road.

25 Rowood Road from Airport Boulevard to Bentwood Road.

26 **Area 12:**

27 Cambray Drive from Valleyfield Drive to the end of Cambray Drive.

1 Mayview Drive from Valleyfield Drive to Decker Lane.

2 Meadow Bend Drive (East) from Colony Loop Drive to Valleyfield Drive.

3 Smallwood Drive from Valleyfield Drive to the end of Smallwood Drive.

4 View Ridge Drive from Valleyfield Drive to Meadow Bend Drive (East).

5 **PART 3.** The City Council finds that the prima facie speed limit previously applicable to  
6 the streets, or portions of streets, identified in Parts 1 and 2 of this ordinance is  
7 unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the  
8 potential for vehicle-pedestrian accidents.

9  
10 **PART 4.** The amendments made in this ordinance shall be incorporated in alphabetical  
11 order in Section 12-4-64(D) (*Table of Speed Limits*).

13 **PART 5.** This ordinance takes effect on \_\_\_\_\_, 2008.
