

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS BOUNDED BY EAST 11TH STREET/ROSEWOOD AVENUE TO THE SOUTH, EAST MARTIN LUTHER KING, JR. BOULEVARD TO THE NORTH, MIRIAM AVENUE TO THE EAST, AND I. H. 35 FRONTAGE ROAD NORTHBOUND TO THE WEST.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

Cedar Avenue between Rogers Avenue and 12th Street (East) [~~Martin Luther King, Jr. Boulevard (East)~~].

Leona Street between Manor Road and New York Avenue [~~Martin Luther King, Jr. Boulevard (East)~~].

Lydia Street from 7th Street (East) to Juniper Street [~~11th Street (East)~~].

Maple Avenue between Manor Road and 16th Street (East) [~~Martin Luther King, Jr. Boulevard (East)~~].

Poquito Street between Manor Road and 11th Street (East) [~~Martin Luther King, Jr. Boulevard (East)~~].

[~~Poquito Street between Rosewood Avenue and 11th Street (East).~~]

Salina Street [~~from~~] between Manor Road and 12th Street (East) [~~Martin Luther King, Jr. Boulevard (East)~~].

PART 2. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Alamo Street from Rosewood Avenue to 185 feet north of Pennsylvania Avenue.

Alamo Street from 12th Street (East) to 17th Street (East).

1 Amber Street from Navasota Street to Waller Street.

2 Angelina Street from 13th Street (East) to 14th Street (East).

3 Branch Street from 11th Street (East) to 12th Street (East).

4 Catalpa Street from Branch Street to Navasota Street.

5 Coletto Street from Rosewood Avenue to 16th Street (East).

6 Concho Street from 13th Street (East) to 14th Street (East).

7 Cotton Street from Navasota Street to Comal Street.

8 Curve Street from 11th Street (East) to Catalpa Street.

9 13th Street (East) from Comal Street to the east end of 13th Street (East).

10 14th Street (East) from Olander Street to Navasota Street.

11 15th Street (East) from Olander Street to Navasota Street.

12 16th Street (East) from Chicon Street to Miriam Avenue.

13 17th Street (East) from Leona Street to Salina Street.

14 17th Street (East) from Chicon Street to Miriam Avenue.

15 18th Street (East) from Leona Street to Poquito Street.

16 18th Street (East) from Miriam Avenue to west end of 18th Street (East).

17 Ferdinand Street from 18th Street (East) to Martin Luther King, Jr. Boulevard
18 (East).

20 Juniper Street from Branch Street to Navasota Street.

21 Maple Avenue from 12th Street (East) to 13th Street (East).

1 Miriam Avenue from 16th Street (East) to Martin Luther King, Jr. Boulevard
2 (East).

3
4 Myrtle Street from Waller Street to Navasota Street.

5 Navasota Street from Juniper Street to 16th Street (East).

6 New York Avenue from Comal Street to Chestnut Avenue.

7 Olander Street from 12th Street (East) to 14th Street (East).

8 Olive Street from Branch Street to Navasota Street.

9 Pennsylvania Avenue from Leona Street to Chestnut Avenue.

10 S L Davis Avenue from Chestnut Avenue to Chicon Street.

11 Short Hackberry from Navasota Street to east end of Short Hackberry.

12 Singleton Avenue from 12th Street (East) to Martin Luther King, Jr. Boulevard
13 (East).

14
15 Ulit Avenue from 14th Street (East) to Martin Luther King, Jr. Boulevard (East).

16 Waller Street from 11th Street (East) to 16th Street (East).

17 Walnut Avenue from 12th Street (East) to Martin Luther King, Jr. Boulevard (East).

18 **PART 3.** The City Council finds that the prima facie speed limit previously applicable to
19 the streets, or portions of streets, identified in Parts 1 and 2 of this ordinance is
20 unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the
21 potential for vehicle-pedestrian accidents.

23 **PART 4.** The amendments made in this ordinance shall be incorporated in alphabetical
24 order in Section 12-4-64(D) (*Table of Speed Limits*).
