SUMMARY STAFF RECOMMENDATION: Staff does not recommend the proposed zoning change from single family residence, neighborhood plan combining district (SF-3-NP) to single family residence, neighborhood plan – Historic (SF-3-H-NP) combining district zoning.

HISTORIC LANDMARK COMMISSION ACTION: **September 24, 2007:** Initiated the historic zoning case. Vote: 5-0 (Cuppett absent, Bunton, Mather, and Leary off dais). **October 22, 2007:** Postponed the case to November 19, 2007. **November 19, 2007:** Recommended historic zoning. Vote: 7-0 (Bunton and Rosato ill).

PLANNING COMMISSION ACTION: Recommended the proposed zoning change from single family residence, neighborhood plan combining district (SF-3-NP) to single family residence, neighborhood plan – Historic (SF-3-H-NP) combining district zoning. Vote: 7-0.

DEPARTMENT COMMENTS: The house is listed in the East Austin Survey (1980) as a Priority 1; it had board-and-batten siding across the front at that time.

BASIS FOR RECOMMENDATION:

While the house is an excellent example of a vernacular Victorian wing-and-gable house, it lacks the historical significance necessary for designation as an individual landmark.

Architecture:

One-story wing-and-gable plan frame house with a partial-width independent shed-roofed porch on plain square wood posts; transom over front door; 4:4 fenestration with 6:1 screens. The house originally had board-and-batten siding; now it has vinyl siding.

Historical Associations:

The address first appears in the 1906-07 city directory as the home of Thomas C. Burch, a carpenter, and Thomas V. Burch, an employee of the Southern Bedding Company. The 1905 city directory shows Thomas C. Burch as a carpenter living at 2007 Guadalupe Street. The Burches lived in this house until at least 1918; Thomas C. was married to Beulah; in the 1918 directory, he is shown as a renter of the house and did not list his occupation; Thomas Van Burch is listed as a carpenter. The house was occupied by renters until 1924, when Robert G. White and his wife Emma are listed as the owners. White did not list his occupation in the directory. Henry H. Patten, a machinist at the Southern Pacific Shops is listed as the owner with his wife Mabel, in 1927. In the 1930-31 directory, Ross S. and Beulah Ott are listed as the owners; he was a carpenter. In 1932-33, Ernest T. Siggell and his wife Alma are listed as the owners; he was an ornamental iron worker at 403 W. 2nd Street. By 1937, Carl E. Jackson and his wife Anna Belle, are listed as the owners and occupants. Jackson was a welder and machinist for Austin Machine and Grinding Company, 219 E. 5th Street, while Anna Belle was a waitress at the Travis Café, 616 Colorado Street in the mid-1940s and at Snyder's Smart Shop, a women's clothing store at 714 Congress in the late 1950s. Carl Jackson was working as a laboratory machinist at the University of Texas by 1949; he continued that occupation until the 1960s – he is listed as a salesman for Charles P. David Hardware in 1969, and retired thereafter.
