The Water and Wastewater Commission recommends approval of a resolution authorizing the filing of eminent domain proceedings for the **Austin Clean Water Program: Govalle 2 – Harper's Branch Wastewater Improvement Project** for a 2,556 square-foot permanent wastewater line easement, a 2,826 square-foot permanent access easement, a 22,259 square-foot temporary working space easement and temporary staging area and material storage site easement, rental of 70 parking spaces for 19 months, and additional insurance premium for parking spaces, out of Tract A, Teague Buda Subdivision No. One, a subdivision in Travis County, Texas, in the amount of \$127,046. The owner of the needed property is **Aberfeldy II Limited Partnership**, a Texas limited partnership. The property is located at **1524 South IH 35**, Austin, Travis County, Texas.
