1 **AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE**  
2 **PROPERTY LOCATED AT 507 WEST 18<sup>TH</sup> STREET FROM GENERAL OFFICE**  
3 **(GO) DISTRICT TO DOWNTOWN MIXED USE-CONDITIONAL OVERLAY**  
4 **(CMU-CO) COMBINING DISTRICT.**

6 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

7  
8 **PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to  
9 change the base district from general office (GO) district to downtown mixed use-  
10 conditional overlay (DMU-CO) combining district on the property described in Zoning  
11 Case No. C14-2008-0047, on file at the Neighborhood Planning and Zoning Department,  
12 as follows:

13  
14 Lot 9, Outlot 28, Division E, Original City of Austin, according to the map or plat  
15 of record in Plat Book 2, Page 146, of the Plat Records of Travis County, Texas  
16 (the "Property"),

17  
18 locally known as 507 West 18<sup>th</sup> Street, in the City of Austin, Travis County, Texas, and  
19 generally identified in the map attached as Exhibit "A".

20  
21 **PART 2.** The Property within the boundaries of the conditional overlay combining district  
22 established by this ordinance is subject to the following conditions:

23  
24 A site plan or building permit for the Property may not be approved, released, or  
25 issued, if the completed development or uses of the Property, considered cumulatively  
26 with all existing or previously authorized development and uses, generate traffic that  
27 exceeds 2,000 trips per day.

28  
29 Except as specifically restricted under this ordinance, the Property may be developed and  
30 used in accordance with the regulations established for the downtown mixed use (DMU)  
31 base district, and other applicable requirements of the City Code.
