

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 105 firms on November 7, 2007. The RFQ was obtained by 35 firms, and five firms submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the two firms evaluated, both firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following recommendation:
