

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY WEST STASSNEY LANE, MANCHACA ROAD, WEST WILLIAM CANNON DRIVE, AND WEST GATE BOULEVARD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Aldford Circle from Aldford Drive to the end of Aldford Circle.

Aldford Drive from Krollton Drive to the end of Aldford Drive.

Amur Drive from Blarwood Drive to the end of Amur Drive.

Baxter Drive from Blarwood Drive to Berkeley Avenue.

Berkeley Cove from Berkeley Avenue to the end of Berkeley Cove.

Berkett Cove from Berkett Drive to the end of Berkett Cove.

Berry Hill Circle from Berry Hill Drive to the end of Berry Hill Circle.

Berry Hill Drive from Stassney Lane (West) to Harwick Drive.

Berwyn Circle from Buffalo Pass to the end of Berwyn Circle.

Berwyn Lane from Brookhill Drive to Buffalo Pass.

Boleynwood Drive from Campden Drive to Aldford Drive.

Brickford Cove from West Gate Boulevard to the end of Brickford Cove.

Bridlington Circle from Berkett Drive to the end of Bridlington Circle.

Brookhill Drive from Falcon Hill Drive to Berwyn Lane.

Burnhill Drive from Coatbridge Drive to Stoutwood Circle.

Campden Drive from Berkeley Avenue to Aldford Drive (north intersection).

Cannes Circle from Berkett Drive to the end of Cannes Circle.

Carlow Drive from Baxter Drive to Blarwood Drive.

Channing Circle from West Gate Boulevard to the end of Channing Circle.

Coatbridge Drive from West Gate Boulevard to Buffalo Pass.

Cockburn Drive from Blarwood Drive to Berkeley Avenue.

Collins Street from Buffalo Pass to the end of Collins Street.

Cornish Circle from West Gate Boulevard to the end of Cornish Circle.

Falcon Hill Drive from Brookhill Drive (east intersection) to Brookhill Drive (west intersection).

Gateshead Circle from Buffalo Pass to the end of Gateshead Circle.

Gateshead Drive from Buffalo Pass to the end of Gateshead Drive.

Harwick Drive from Lewood Drive to Berry Hill Drive.

Hillston Drive from Buffalo Pass to the end of Hillston Drive.

Kinbrake Drive from Burnhill Drive to Gateshead Drive.

Krollton Drive from Campden Drive to Aldford Drive.

Lewood Circle from Lewood Drive to the end of Lewood Circle.

Lewood Drive from Stassney Lane (West) to Whitestone Drive.

Lloyds Lane from Falcon Hill Drive to the end of Lloyds Lane.

Mc Gregor Drive from Blarwood Drive to Berkeley Avenue.

Shier Cove from William Cannon Drive (West) to the end of Shier Cove.

Standish Drive from Whitestone Drive to Berwyn Lane.

Stoutwood Circle from Gateshead Drive to Stassney Lane (West).

Whitestone Drive from Manchaca Road to Berry Hill Drive.

Wilton Circle from Blarwood Drive (north intersection) to Blarwood Drive (south intersection).

PART 2. The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.

PART 3. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 4. This ordinance takes effect on _____, 2008.
