

**ORDINANCE NO. 20080515-029**

**AN ORDINANCE AUTHORIZING THE ADDITION OF NEW  
NEIGHBORHOODS TO THE RESTRICTED PARKING AREA MAP IN  
ACCORDANCE WITH SECTION 12-5-29 OF THE CITY CODE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

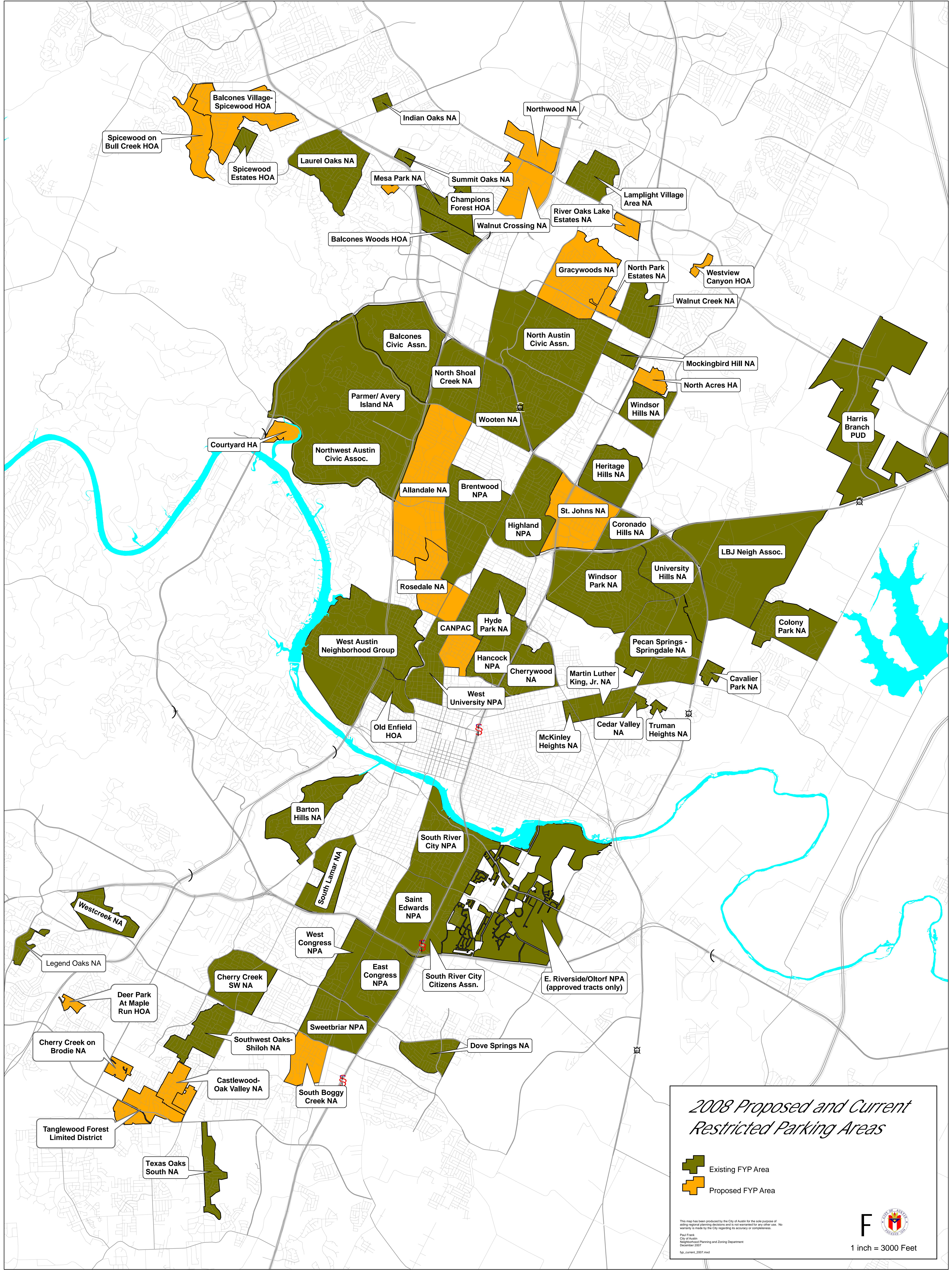
