

Bid documents were distributed to 15 general contractors. Bids were opened on May 1, 2008. The low bidder, AAR, Inc., submitted the lowest compliant bid of the five bids received:

The contractor's choice of work methodology provides for three areas of subcontracting opportunities: Hauling Services, site work, and electrical work.

Project specific subgoals stated in the solicitation were 3.23% African American; 3.66% Hispanic; 0.38% Native/Asian American, and 1.08% WBE. Total participation is estimated on the base bid amount of \$299,750.00:
