AN ORDINANCE AUTHORIZING EXECUTION OF AN ADVANCED FUNDING AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION AND ACCEPTANCE OF FUNDS; AND AMENDING THE FISCAL YEAR 2007-2008 PARKS AND RECREATION DEPARTMENT OPERATING BUDGET SPECIAL REVENUE FUND OF ORDINANCE NO. 20070910-003 AND CAPITAL BUDGET OF ORDINANCE NO. 20070910-004 TO APPROPRIATE FUNDS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
