SPECIAL MEETING OF THE CITY COUNCIL:

Austin. Texas, May 28, 1938.

The City Council met in special session at the regular meeting place at 10:30 A.M., May 25,1935, with Mayor Tom Miller presiding. Roll call showed the following members present: Councilmen C. F. Alford, C. M. Bartholomew, Simon Gillis, and Mayor Tom Miller; absent, Councilman Oswald G. Wolf.

Mayor Miller introduced the following ordinance:

AN ORDINANCE AMENDING IN CERTAIN PARTICULARS AN ORDINANCE RELATING TO TRAFFIC AND REGULATING THE USE OF PUBLIC STREETS AND HIGH-WAYS IN THE CITY OF AUSTIN, BY WHICH THE PARKING METER ZONES ARE AUTHORIZED AND PROVISION IS MADE FOR THE INSTALLATION, OPERATION, MAINTENANCE, SUPERVISION, REGULATION AND CONTROL OF THE USE OF PARKING METER SPACES AND PARKING METERS AND THE MAINTENANCE AND INSTALLATION OF PARKING METERS, WHICH SAID ORDINANCE WAS PASSED BY THE CITY COUNCIL AUGUST 19, 1937, AND IS RECORDED IN BOOK "K", PAGES 261-265, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN, BY THE AMENDMENT OF WHICH IN THIS ORDINANCE ADDITIONAL STREETS ARE INCLUDED WITHIN THE PARKING METER ZONE AND THE TIME LIMITATION FOR CONTINUOUS PARKING ON CERTAIN STREETS IS FIXED AT TWO HOURS, AND DECLARING AN EMERGENCY.

The ordinance was read the third time, and upon motion of Councilman Gillis,

seconded by Councilman Alford, the ordinance was finally passed, by the following vote: Ayes, Councilman Alford, Bartholomew, Gillis, and Mayor Miller; nays, none; Councilman Wolf absent.

Councilman Alford offered the following resolution:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the sum of \$350.00 be, and the same is, hereby appropriated out of the General Fund, not otherwise appropriated, for the purpose of purchasing one section plat card file for the Tax Office.

The resolution was adopted by the following vote: Ayes, Councilmen Alford, Bartholomew, Gillis, Mayor Miller; nays, none; Councilman Wolf absent.

Councilman Gillis offered the following resolution:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the sum of \$650.00 be, and the same is hereby, appropriated out of the General Fund, not otherwise appropriated, for the purpose of purchasing cash registers for Barton Springs and Deep Eddy bath houses.

The resolution was adopted by the following vote: Ayes, Councilmen Alford, Bartholomew, Gillis, and Mayor Miller; nays, none; Councilman Wolf absent.

Councilman Alford offered the following resolution:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the sum of \$125.00 be, and the same is hereby, appropriated out of the General Fund, not otherwise appropriated, for the purpose of providing the City Finance Office with coin counting and wrapping machine.

The resolution was adopted by the following vote: Ayes, Councilmen Alford, Bartholomew, Gillis, and Mayor Miller; nays, none; Councilman Wolf absent.

Councilman Alford offered the following resolution:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

THAT the sum of \$900.00 be, and the same is hereby, appropriated out of the General Fund, not otherwise appropriated, for the purpose of increasing the salaries of Police and Fire Chiefs from \$250.00 to \$300.00 per month each, effective April 1, 1935.

The resolution was adopted by the following vote: Ayes, Councilmen Alford, Bartholomew, Gillis, and Mayor Miller; nays, none; Councilman Wolf absent.

Upon motion, seconded and carried, the meeting was recessed at 11:55 A. M., subject to call of the Mayor.
