ORDINANCES; AND DECLARING AN EMERGENCY, "WHICH ORDINANCE
WAS PASSED BY THE CITY COUNCIL OF THE CITY OF AUSTIN
DECEMBER 15, 1938, AND IS RECORDED IN BOOK "K", PAGES
1440-1452, OF THE ORDINANCE RECORDS OF THE CITY OF AUSTIN,
BY AMENDING SUBPARAGRAPH 1, SECTION 13(A), RELATING TO
THE AGE REQUIREMENT OF TAXICAB DRIVERS, AND BY ADDING
TO SECTION 13 ANOTHER SUBSECTION, SUBSECTION (1), RELATING TO REVOCATION OR SUBPENSION OF TAXICAB DRIVERS'
LICENSES; AND DECLARING AN EMERGENCY.
