A Proclamation by the Mayor proclaiming the week of September 26-October 3 as "THIRTEENTH ANNUAL RELIGIOUS EDUCATION WEEK," was approved.

There being no further business, upon motion seconded and carried, the meeting was recessed at 11:10 A. M., subject to call of the Mayor.

WHEREAS, R. K. Bonser is the Contractor for the alteration of a building located at 121-123 East oth Street and desires a portion of the sidewalk and street space abutting the east part of Lots 7 and 5, Block 42, of the Original City of Austin, Texas, during the alteration of the building, such space to be used in the work and for the storage of materials therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

1. THAT space for the uses hereinabove enumerated be granted to said R. K. Bonser, the boundary of which is described as follows:

Sidewalk and Street Working Space

Beginning at the northwest corner of the above described property and at right angles with the centerline of East 5th Street, north six feet to a point; thence in an easterly direction and parallel with the centerline of East 5th Street, approximately 45 feet west to a point; thence in a southerly direction and parallel with the centerline of Brazos Street, approximately 50 feet to a point; thence in a westerly direction, and at right angles with the centerline of Brazos Street, to the east line of the above described property.

Beginning at the west curb line of Brazos Street and the southeast corner of the above described property and at right angles with the centerline of Brazos Street; thence in an easterly direction fourteen feet to a point; thence in a northerly direction and paralel with the centerline of Brazos Street, approximately 25 feet to a point; thence in a westerly direction and at right angles to the centerline of Brazos Street to the west curb line of said street.

2. THAT the above privileges and allotment of space are granted to the said R. K. Bonser, herein-after termed "Contractor," upon the following express terms and conditions:

- (1) That the contractor shall construct a guard rail within the boundary line along the north, south, east, and west lines of the above described space, such guard rail to be at least four feet high and substantially braced and anchored.
- (2) That no vehicles in loading or unloading material at the working space shall park on any part of the street outside of the allotted working space.
 - (3) That "No Parking" signs shall be placed on the street side of the barricades.
- (4) That the contractor shall in no way obstruct any fire plugs or other public utilities in the construction of such barricales.
- (5) That provisions shall be made for the normal flow of all storm waters in the gutter, and the contractor will be responsible for any damage done due to obstruction of any such storm water.
- (6) That the contractor shall place on the outside corners of any walkway barricades or obstructions, red lights during all periods of darkness and provide lighting system for all tunnels.
- (7) That the contractor shall remove all fences, barricades, loose materials, and other obstructions on the sidewalk and street immediately after the necessity for their existence on said sidewalk or street has ceased, such time to be determined by the City Manager, and in any event all such sidewalk, barricades, materials, equipment, and other obstructions shall be removed not later than December 1,1943.
- (8) That the City reserves the right to revoke at any time any and all the privileges herein granted, or to require the erection or installation of additional barriers or safeguards if the conditions demand it.
- (9) That the use and enjoyment of the spaces herein granted shall not be exclusive as against public needs, and the City, in making such grant, reserves the right to enter and occupy any part or all of said space any time with its public utilities, or for other necessary public purposes.
- (10) That any public utility, or public or private property disturbed or injured as a result of any of the activities necessary for the completion of the construction work for said building projects, whether done by the Contractor, City forces, or public utilities, shall be replaced or repaired at the Contractor's expense.

(11) That the contractor shall furnish the City of Austin a surety bond in the sum of One Thousand and No One Hundredths Dollars (\$1000.00), which shall protect, indemnify, and hold harmless the City of Austin from any claims for damages to any person or property that may accrue to or be brought by any person by reason of the exercise or abuse of the privileges granted the contractor by the City of Austin, and shall guarantee the replacement of all sidewalks, pavement, and all other public property and public utilities disturbed or removed during the construction work, and shall further guarantee the construction of a walkway and other safeguards during the occupancy of the space.

The City Council convened in Regular Session at the regular meeting place in the Council Chamber at the Municipal Building on Thursday, October 7, 1943, at 10:35 A. M., with Mayor Tom Miller presiding. Roll call showed the following members present: Councilmen Alford, Bartholomew, Gillis, and Mayor Miller; absent, Councilman Wolf.
