

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 132 firms on January 31, 2008. The RFQ was obtained by 44 firms, and five firms submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the five firms evaluated, two firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following recommendation:
