ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY EAST 51ST STREET, MANOR ROAD, AND SPRINGDALE ROAD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Ameswood Drive from Claymoor Drive to Rexford Drive.

Basswood Lane from Highbury Lane to Tipton Drive.

Beechmoor Drive from Basswood Lane to Norwood Hill Road.

Berrylawn Circle from Reicher Drive to the end of Berrylawn Circle.

Cedarlawn Circle from Walnut Hills Drive to the end of Cedarlawn Circle.

Cherrylawn Circle from Walnut Hills Drive to the end of Cherrylawn Circle.

Claymoor Drive from Norwood Hill Road to Woodbriar Lane.

Cordell Lane from Claymoor Drive to Rexford Drive.

Darlington Lane from Norwood Hill Road to Rexford Drive.

Darlington Cove from Norwood Hill Road to the end of Darlington Cove.

Dresden Cove from Darlington Lane to the end of Dresden Cove.

Edgedale Drive from Gloucester Lane to Reicher Drive.

Gladstone Drive from Basswood Lane to Norwood Hill Road.
