ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS BOUNDED BY ELMONT DRIVE AND COUNTRY CLUB CREEK, EAST RIVERSIDE DRIVE, SOUTH PLEASANT VALLEY ROAD, AND MONTOPOLIS DRIVE; AND TO CORRECT ENTRIES IN SECTION 12-4-64(D).

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Atwood Street from Kemp Street to the end of Atwood Street.

Begonia Circle from Begonia Terrace to the end of Begonia Circle.

Begonia Terrace from Carnation Terrace to Palm Circle.

Bluebell Circle from Marigold Terrace (north intersection) to the end of Bluebell Circle.

Brassie Street from Riverside Drive (East) to Fairway Street.

Caddie Street from Montopolis Drive to Clubview Avenue.

Caladendra Drive from Carnation Terrace to Marigold Terrace.

Carnation Terrace from Montopolis Drive to the end of Carnation Terrace.

Clovis Street from Kemp Street to Montopolis Drive.

Club Terrace from Montopolis Drive to Community Drive.

Community Drive from Hogan Avenue to both ends of Community Drive.

Country Club Road from Riverside Drive (East) to the end of Country Club Road.

Culp Street from Ponca Street to the end of Culp Street.

1	Egger Street from Ponca Street to the end of Egger Street.
2	Felix Avenue from Montopolis Drive to Community Drive.
3	Grove Drive from Montopolis Drive to the end of Grove Drive.

20 21 22	PART 2. The following entries in Section 12-4-64(D) (<i>Table of Speed Limits</i>) are corrected to read:

Edinburgh Cove from Robert Burns Drive to the end of Edinburgh Cove.

1	Jaffna Cove from Kandy Drive to the end of Jaffna Cove [Drive].
2 3	PART 3. The City Council finds that the prima facie speed limit previously applicable to
4 5	the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for
6	vehicle-pedestrian accidents.
7 8	PART 4. The amendments made in this ordinance shall be incorporated in alphabetical
9	order in Section 12-4-64(D) (Table of Speed Limits).
10	PART 5. This ordinance takes effect on, 2008.
