

Minutes of a Regular Meeting of the City Council.
City of St. Louis, Mo. Nov. 7th 1896.

Petitions

Pet. of Citizens of 4th Ward By Alderman Platt, Petition of Citizens of the 4th Ward to open & grade street West side of Tillotson Institute. Read and referred to the Street Committee and City Engineer.

Pet. of W. Stamps for remission of fine in Recorder's Court. The Mayor laid before the Council a petition from Willie Stamps asking the Council to remit a fine imposed upon him in the Recorder's Court.

Report of Water and Light Committee on proposition of M. M. Shippe in regard to water pipe laid in Hyde Park. Alderman Tolin, for the Water and Light Committee, to whom was referred the proposition of M. M. Shippe, President of the Missouri, Kansas and Texas Land and Town Company, in regard to pipe in Hyde Park, presented the following report which was adopted.

Austin, Texas, Nov. 7th 1896.

Hon. Mayor and City Council:

Gentlemen, Your Committee on Water and Light to whom was referred the proposition of M. M. Shippe, President of the Missouri, Kansas and Texas Land and Town Company, to transfer to the City the system of water pipes belonging to said Company in Hyde Park, beg leave to report that we have carefully examined into the matter, and find that the City has been using said system since April 15th 1895, and that there are fifty-five water towers connected therewith. We find that the total amount at which said system is proposed to be transferred for is \$1937.37 at the prices agreed upon, which is much less than it would cost to connect the said fifty-five consumers with the City mains.

We recommend that the proposition of Mr. Shippe be accepted and that the sum of \$1937.37 be allowed for said pipe system, to be paid as indicated in the proposition.

Ord. Approp'g \$25. for Feeds
Repairs for South Austin Co. No. 5

To the Hon. City Council:

Gentlemen, I herewith return to you an ordinance passed by you on the 14th day of October, "appropriating the sum of \$25. for the purpose of paying for feed and repairs for South Austin Co. No. 5," with my disapproval and reasons therefor as follows:
The sum hereby appropriated, as set forth in the body of the ordinance, is for the month of November, and would commit the City to an additional outlay of \$300 per year. I recognize the great usefulness of the fire department and the earnestness and self-sacrifice of its members, and am ready at all times to favor such encouragement as is within the City's means.

Especially in the case of South Austin Company, No. 5, which at present receives only \$75 per month, as against \$100 per month paid the other companies, it would be a satisfaction to me to see this inequality removed and the appropriation made. But, in my opinion, the financial condition of the City does not at this time warrant such an expenditure. Before this message reaches you, I shall have occasion to lay before you in more detail the budget for the ensuing year, showing the necessity for rigid economy, and probably an increase of the tax rate. In view of these facts, and in view of the fact that we have just admitted a company from the northern portion of the City upon the understanding that they should not expect any money from the City during this or the next fiscal year, I am compelled to disapprove this ordinance.
